Chapter-One

ARTICLE - 1

NAME OF THE PARTY-

Voters Party International, hereafter it will be mentioned as the party.

1.1 PREFACE OF THE PARTY CONSTITUTION

Objectives of the Party are as under:-

By implementing the essential political, legal and constitutional reforms;

Establishing rule of democratic law, not only at the level of country but at the level of world also;

Identifying and recognizing the horizontal and vertical sovereignty and general will of the masses and that of the state, getting them recognized, getting representation in the decision making process of the state for all kinds of general wills and all types of sovereignties;

Making available the economic, political opportunities for all the citizens of the world-democracy, fraternity and equality;

Evolving a competent political and economic world order on the basis of justice for all to eliminate the circumstances from the whole world creating violence, economic slavery, poverty and environmental imbalances.

1.2 POLICY OF THE PARTY

Solution of the problems of citizens of the world will be worked out by the world citizens for the citizens of entire world.

1.3 PRINCIPLES, PHILOSOPHY AND ASSUMPTIONS OF THE PARTY-

The members of the party will study to understand and to believe in the following assumptions-

- 1.3.1 In the literature written by the contemporary political reformer shri Bharat Gandhi, consists the total view points of the great men and philosophers of the past and real solutions all those contemporary problems which can be solved by the machinery of the state. It contains also the information of feasible solutions to cope up with the challenges, likely to be created in future, and of their remedies, workable in present.
- **1.3.2** All the homo-sapiens of the entire earth behave like the cells of a common body. Therefore, as no organ of the body can be treated, separating it apart from the body, likewise no permanent problems of any country can be solved, by separating it apart from the whole world.
- 1.3.3 Human beings and the earth, both are created by nature. Hence, going to and from on the entire earth is their fundamental right, the violation of which should be treated as the violation of fundamental rights. The entry in the house can be prohibited only by the house-maker, likewise entry in the earth any where can be prohibited only by the maker of the earth. The methods and traditions like Visa, to check violence and terrorism in the world, have themselves become the causes of violence and extremist terrorism. These prevalent traditions and methods regarding visa are based on political superstitions, their elimination is indispensible to combat the violence and terrorism from the world.
- 1.3.4 As the longevity of the body of every individual is fixed, likewise the age of the human society is also fixed. The changes occur in the body and mind of the individual, along with age. Likewise changes come in the nature of society with the growing age. Hence the values, faiths and rules of communities have no eternal longevity. After a period their forms change.
- **1.3.5** The ecstasy and pleasure cannot be created, neither can it be destroyed. It is only transferred from consciousness to body, from one individual to another, from one community to the other, from the country to another country and from one living species to another living world, mutually.

- **1.3.6** Strength is not provided by the nature to assault some weaker one, but it is provided to protecting the weak.
- **1.3.7** To decentralize one thing, it is necessary to centralize some other thing. Centralization is news for decentralization. Hence the energy of the party will be applied, instead of preventing centralization, to disseminate the advantages of centralization to the decentralized units, to the extent of each and every individual.
- **1.3.8** Money is an item, produced by a collective enterprise. Hence, to get money, it is essential to renounce private values.
- 1.3.9 In the private income of an individual; share of political system of producing paper money, share of laws and share of nature is also included. This share is more to the extent of the private money more than average any person has.
- 1.3.10 Two communities, between which an historical enmity is apparent, and two ideologies which appear mutually hostile to each other, are like two electrical wires of earth and phase. If they are directly connected with each other, there is sparking, and if joined together connecting through a resistance a bulb is made, which shades light everywhere. Likewise mutually hostile ideologies and communities are harming to each other but beneficial to the group requirement of humanity. Hence, the party believes in peaceful and democratic forms of expression of dissent. The party declares that it will not in any manner promote or instigate or participate in violence.
- **1.3.11** Functioning of the party will be totally democratic in real sense. The decisions of the party will be taken by the views of majority of representative bodies of respective level and respective organ.
- **1.3.12** The party must contest an election conducted by the Election Commission within five years of its registration and thereafter should continue to contest.

1.4 OBJECTIVES OF THE PARTY

Party will work to achieve the following objectives-

- **1.4.1** To perform the functions of second schedule of the party constitution.
- **1.4.2** To work for transparency in government and in the market.
- **1.4.3** To transfer their ownership in the optimum productive hands, for evaluating transparently the public and private properties.
- **1.4.4** To implement the proposal of Votership lying under consideration by the Indian parliament as a measure for inclusive growth.
- **1.4.5** To work for co-existence of mutually hostile representative ideologies.
- **1.4.6** To work for conditional world-citizenship.
- **1.4.7** To work for recognition of the birth economic and political rights of the voters and to implement them.
- **1.4.8** To work for developing citizens of the country as a strong country and every family and citizen of India as a strong family and strong citizen.
- **1.4.9** To work for evolving and implementing such political, legal and constitutional reforms to pay the persons and institutions working for economic security and growth of economic interests the voters.

1.5 ACTIVITIES OF THE PARTY-

To achieve of the principles and objectives of the party by non-violent and democratic means, the activities of the party will be as under:

- **1.5.1** Conduct welfare activities for lower economic classes.
- **1.5.2** To do networking of individuals, followers of different political and spiritual leaders, communes and ashrams groups, non-government organization, movements, campaigns, schools alleges and universities, research centers, trusts, firms and companies.
- **1.5.3** To affiliate and authorize different parties, institutions, organizations and trusts for various activities of the party.
- **1.5.4** To affiliate and authorize different institutions, organizations, Trusts, firms and companies for various activities of the party.
- **1.5.5** To form alliance of different political parties, institutions, organizations and trusts for various activities of the party.
- **1.5.6** To work for membership and signature are campaigns, public awakening marches and traversing on feet, peaceful picketing, demonstration and rallies, fasts, hunger strikes, seminars and mass meetings, training and work shaps, organizing education

and training carufs for the inborn political and economic rights of the voters, publication of journals and periodicals, conducting radio and T.V. channels.

1.6 FLAG OF THE PARTY

Due to the commitment to work for vertical separation of power, the party will initiate a new trend of using multiple flags for various governing levels of the party. Initially the party will use only one flag, but after the evolution of executive committees of upper vertical levels the party will allow these executives to use the flags deferent from the lover vertical levels to identify the natural level of political affinity of respective Active Members of the party. There will be totally three to four colors in the flags of executive committees of various levels of the party. The two third right part of the flag will be divided upward and downward with two to three equally broad strips. To use the deferent flags for executive committees of deferent levels of the party the following rules will be kept in mind:

- **1.6.1** At the left side of the flag there will be a one third part will be white. The white color will be common in the flags of executive committees of all levels.
- **1.6.2** In the flag of the central committee two third right part will contain two colors. The right upper strip will be red and the right lover strip will violet.
- **1.6.3** To identify the governing level of the party and the level of affinity of respective Active Member, there will be third strip between two strips of flag of central Committee, situated in two third right side of the flag. The height of this central strip will be one fourth of upper and lower strips.
- **1.6.4** Color of central strip of flag of province level will be blue, of country level will be sky, of homeland level will be green, of Hemi-national level will be yellow, of national level will be orange.
- 1.6.5 The different colors of the central strip on the two third parts at the right side will communicate the respect of horizontal and vertical diversity of thoughts of members of the party. Thus the party flag is made on the basis of its mono-duelist (dwaitadwait) thought of sovereignty. By the presence of all colors, party wants to give the message that it belongs to all.
- **1.6.6** At the central strip the name of respective governing level may be written to communicate the party level.
- **1.6.7** The election symbol of the party may be printed on the right top red colored strip.
- **1.6.8** The regional executive committees by permission of central Executive Committee, will have the right to mark any unique sign on the left white part of the flag in order to have one's own identity.

ARTICLE -2

ELECTION SYMBOL

After the registration of the party, the election symbol of the party will be decided by the central executive committee.

Chapter-Two

ARTICLE -3

FAITH AND ALLEGIANCE OF THE PARTY TO THE CONSTITUTION OF INDIA

Voters Party International shall bear true faith and allegiance to the constitution of India as by law establish and to the principles of socialism, secularism and democracy and would uphold the sovereignty, unity and integrity of India.

4.4 POLICY DIRECTOR

The founder Central Executive Committee of the party has accepted Sh. Bharat Gandhi as the mentor of the party. Therefore he shall propose or any organization authorized by him shall propose the name of a person to be nominated as the Policy director of the Party. The name proposed in such a manner will be considered by the central Executive Committee of the party to appoint him/her as the Policy Director of the Party.

4.5 PARTY ALLIANCE

Party shall follow the rules made by an alliance which shall be conducted with the Global organization for Democracy (GOD).

CHAPTER-FOUR

ARTICLE -5

MEMBERSHIP

5.1 QUALIFICATION FOR MEMBERSHIP

Any person who-

- 5.1.1 Is the citizen of India;
- 5.1.2 has completed the age of 18 years;;
- 5.1.3 believes in the constitution of the party;
- 5.1.4 Is not the member of any other political party registered by the Election Commission of India;
- 5.1.5 Applies according to the Form-1 decided for availing the Primary membership of the party;
- 5.1.6 Pays the membership fees as per rules according to the schedule-3 of the constitution.
- 5.1.7 Submits the application form of membership to the party office and such membership gets registration and acceptance by the party as per rules;
- 5.1.8 party membership will be opened for any adult Indian citizen, who will fall under the eligibility mentioned in above sections;

can become the Primary Member of the party.

5.2 VARAETIES OF MEMBERSHIP

5.2.1 Primary Members - To become Primary Member of the party one have to fulfill the proceedings given in article 5.1 of the party constitution. The applicant for getting Primary Membership shall apply according to the Form-1 decided for availing the Active membership of the party. There will be two types of Primary Members. First will be called Paid Primary Members and the second will be called Recommended Primary Members. The Paid Primary Members will pay the requisite fee for the membership and the Recommended Primary Members will be registered as Primary Members without any fee, just on approval of recommendation of district Executive Committee by the central Executive Committee.

- 5.2.2 **Active Members** The Primary Member, who shall enroll minimum 4 Primary Members for the party, shall be called Active Member of the party. The applicant for getting Active membership shall apply according to the Form-2 decided for availing the Active membership of the party.
- 5.2.3 **Voter Councilor**s- The Primary Member who shall enroll 25 Active Members for the party, shall be called Voter Councilor in short V.C. of the party. The applicant to enroll as V.C. of the party shall apply according to the Form-3 decided for availing the Active membership of the party.
- 5.2.8 **Zero Member**-The person registered in the zero membership register on the basis of recommendation by any Member of the party, will be called the Zero Member of the party. The information regarding Zero member will be sent to the office of the party through the format of Form-4 of the party.
- 5.2.9 Interim Office Bearers-Central Committee may nominate or may authorize office bearers/interim office bearers of the party to nominate someone as Interim Office Bearers of the party looking his/her utility to the party. The information regarding Interim Office Bearers will be sent to the office of the party through the format of Form-5 of the party. The office bearers/interim office bearer who is enrolling someone as interim office bearer will issue a prescribed certificate on format of Form-5.1 to the enrolled person and a copy of the same along with the furnished Form-5 will be sent to the party office for record. Rights and duties of Interim Office bearers will be same as Zero Members of the Party.
- 5.2.10 Office Bearers Only Active Members will have the right to become the office bearer of the party. The applicant willing to join the party as office bearer, shall apply according to the Form-6 decided for availing the post of the party. The concern office bearer of the concerned organ or sub-organ of the party will issue a prescribed certificate on format of Form-6.1 to newly recruited office bearer and a copy of the same along with the furnished Form-6 will be sent to the office of the concerned organ of the party for record.
- 5.2.5 **Fundamental Members** The Fundamental Members of the party alliance will be the ex-officio Primary Members of the party. These members will be recruited by the party alliance and the record of such members will be kept by the party alliance. The rights and duties of the Fundamental Members will be same as the rights and duties of the Zero Members of the Party.
- 5.2.6 **Mission-Friend Members**-Members of the mission-friend parties will be the Mission-Friend Members of the party. The rights and duties of the Mission-Friend Members will be same as the rights and duties of the Zero Members of the Party.
- 5.2.7 **Fraternal Members** The Primary Members of the member parties of the party alliance will be the Fraternal Members of the party. The rights and duties of the Fraternal Members will be same as the rights and duties of the Zero Members of the Party.

5.3 MEMBERSHIP PERIOD AND OATH FOR MEMBERS

- 5.3.1 The membership period of the Primary Member of the party will be 4 Years. The renewal of membership through application form will be essential after 4 Years. Any person can become the member only on the address, where he is living permanently. In case of change of address the member will be required to give notice in written, immediately to the old and new district offices of the party. One person cannot become the member from two or more places.
- 5.3.2 The Primary Member of the party will declare with oath that. I vow
 - 5.3.2.1 to work to achieve the objectives of the party through the procedure determined by it.
 - 5.3.2.2 to make attempt to condition my own working style as for as possible, according to the party constitution.
 - 5.3.2.3 **to** practice to develop the higher equi-scient view point

5.4 REGISTRATION AND RENUAL OF MEMBERSHIP

5.4.1 Any person who is desirous to become the Active Member of the party will apply through the fixed form-one, addressing the executive head of the recruitment council of the Voters Party International. To become the Active Member he/she has to mention a name of any 5 vertical governing executive committees in this application

- form as ones desired and sign on the oath paper. To become the office-bearer or staff worker he/she has to write the name of the concerned cell or organ, in which he/she is especially interested to work.
- **5.4.2** The Recruitment Council will have the right to ask the applicant for the recommendation of any member of the working committee or general assembly, or recruit the applicant on the proper post or at the adequate level as per rules.
- **5.4.3** Recruitment council can do the interim or final registration according to its discretion.
- **5.4.4** The final acceptance will be given by the concerned executive committee.
- **5.4.5** The renewal of the Primary Membership will be made on prescribed application Form No.-1.1 with requisite fee. The renewal fee will be approximately half amount of Primary Membership Fee.

5.5.7 RECORD AND VERIFICATION OF MEMBERSHIP

- 5.5.1 The District Committee shall, publish the preliminary roll of primary and active members enrolled or renewed during the previous term, before the 31st March in every three years. The revised and final roll, after scrutiny shall be published not later than the 31st of August every third year.
- 5.5.2 The final roll published as above shall be in force till the next roll is prepared. Permanent lists or registers of active members shall be prepared by the District executive after being duly certified by the respective governing Executive Committee.
- **5.5.3** All the presidents of vertical executive committees will have right to verify membership through the secretary general of committee of their own level. The right to make rules regarding verification will vested with the central executive committee.

5.6 APPLICATION FOR RESIGNATION AND TRANSFER OF MEMBERSHIP

- 5.6.1 Any member related to the Voters Party International executive committee, general assembly, judicial council or GAP council can give the application for ones resignation or transfer to the executive head of ones unit. Such head will send it to ones higher executive head with ones recommendation for sanction. Such recommendation can have acceptance of the request in the application, or dismissal from membership or its suspension. In such case, the concerned member will have right to go to the concerned judicial council, against the decision of the concerned executive head.
- **5.6.2** Besides the Voters Party International central executive committee, other five executive committees will be free to formulate methods regarding resignation from membership or transfer.

6.7 RIGHTS OF THE MEMBERS

- 6.7.1 The Primary Members of the party will have the right to vote in the presidential election of the central executive committee.
- 6.7.2 The Assistant Active Members of the party will have the right to vote in the election of the president of the Booth Level Committee of the party.
- 6.7.3 Central Executive Committee of the party will have right to form rules regarding the fundamental rights of members, as well as their derived and legal rights.
- 6.7.4 The Active Members will have the right to vote in the election of local representatives of the General Assemblies of only that vertical level of which unit he/she belongs. For example the Active Member of the provincial unit would have right to vote in the election of party representative of the provincial legislative constituency held to constitute the provincial general assembly.
- 6.7.5 The Voter Councilor will have the responsibility to keep regular relation with 100 Primary Members and to renew the membership of 100 Primary Members. He/she will study and advise the voters for the continuous growth of their rights and duties as voters. At the time of elections he/she shall try to find out the reality behind the image of the contemporary hero or villains of the politics build by paid and bribed media and communicate the truth to voters to save them from suicidal voting.
- 6.7.6 Fundamental Members, mission Friend Members, Fraternal Members and Zero Members, will have no right to vote in the organizational elections of the party.

5.8 DUTIES OF THE MEMBERS

Duties of the members will be as under:

- 5.8.8 Convey public expectations to the central executive committee;

5.9 FINANCIAL SOURCES FOR MEMBERS

5.9.1 FINANCIAL SOURCES OF EXISTENTIAL SECURITY OF MEMBERS

- 5.9.1.1 Ones inherited share in the resources created by the works of ancestors, as being a national citizen.
- 5.9.1.2 The fees paid to members by the needful persons.
- 5.9.1.3 The work valuation certifying notes, or refundable donation receipts to be encased through the financial bills passed by the parliament in future.

5.9.2 FINANCIAL SOURCES TO PERFORM THE ORGANIZATIONAL WORKS OF THE PARTY

- 5.9.2 .1 The contribution by the community whose group requirement is fulfilled by the member;
- 5.9.2 .2 The fiscal amount issued on the name of the member for performing ones works by the organization;
- 5.9.2.3 The work valuation certifying notes.

5.10 SOURCES OF INSPIRATION FOR THE WORK

5.10.1 SOURCES OF INSPIRATION FOR THE WORK OF THE NATIONAL MEMBERS

- 5.10.1.1 The national member will work for recognition, security and nourishment of one's collective economic heritage.
- 5.10.1.2 The national member will enable the citizens by enhancing their Private Development Rate (PDR), so that they may utilize the road, electricity and other public means of communication and transport, and fulfill their needs of medicine, food, clothes and house.
- 5.10.1.3 National member will establish the economic justice in terms of distribution by working for carrying the production to all the hands irrespective of ability of mind and money.
- 5.10.1.4 National Members will work for the works schedule for the Global General Assembly.
- 5.10.1.5 Global Developmental Member will work for the growth of production and development of infrastructure of the world.
- 5.10.1.6

5.10.2 SOURCES OF INSPIRATION OF WORK FOR THE MEMBERS OF THE PROVINCIAL COMMITTEE

- 5.10.2.1 Provincial members will work with the motivation of security and nourishment of the cultural heritage of their community.
- 5.10.2.2 Provincial members will work for increasing the Global Development Rate (GDR) and for expansion of traditional means of employment and for development of infrastructure like roads, electricity, communication and transport etc.
- 5.10.2.3 Provincial members will work for more and more production of consumer goods.
- 5.10.2.4 Provincial members will work for allotted work schedule for the Provincial General Assembly.
- 5.10.2.5 Provincial Legislative Member will work to enhance the private economic capacity through political power or social honour availed by him/her.

5.10.3 Sources of inspiration for the work and training of general assemblies of the country, Homeland (Watan) and the hemi- nation (Prarashtra)-

5.10.3.1 The life values and catalysts, inspiring the Provincial and Global members will be opposite and complimentary to each other. Members of these two committees will be inspiration for other three vertical committees of the

- party existing in middle of the said two. The difference will be of only quantity not of quality.
- 5.10.3.2 The members of the Country level assembly will work with inspiration of provincial province level assembly.
- 5.10.3.3 The members of the Hemi-national level assembly will work with inspiration of national level assembly.
- 5.10.3.4 The members of the Homeland level assembly will work to coordinate between the provincial and national level assemblies.

5.11 NATURE OF INCOME, EXPENDITURE AND MEMBERSHIP FEES

5.11.1 Members of executive committees and general assemblies

- 5.11.1.1 The amount of Primary Membership fee as for as possible will be that much amount which should be equal to the sum required to expenses of typing of member's details in register/web page, expenses of half liter petrol as share of the member in the expenses of fee collection charges and expenses of contesting elections from the constituency of the member by party's representative, expenses of 12 times SMS from party to member, expenses of 6 times voice call of the party to member, fare of one time personal visit of an office bearer to the member by public carrier. This amount may vary from one province to another looking the variations in local cost and prices.
- 5.11.1.2 Right to decide Primary Membership fee will lie with the Central Executive Committee of the party. The Central Executive Committee will do this job on the basis of report of the regional executive committees.

5.11.2 Members of executive committee and general assembly

- 5.11.2.1 Development member who will deposit as a fee, the amount of auction after winning the bid of wealthy membership in the open market.
- 5.11.2.2 Legislative member who will take fees in lieu of their service rendered to the party.
- 5.11.2.3 This fees can also be in the form of guarantee note, recognized by party, to be encased in future.

5.11.2 Members of Judicial council

- 5.11.2.1 Judges who will take their fees from the party fund in lieu of services. This fees will be given in the form of refundable donation receipts.
- 5.11.2.2 Advocates, who will take their fees from the concerned petitioners, in lien of other service.
- 5.11.2.3 Advocates, who will plead in favour of the party decisions, will be paid their fees, on behalf of the party. This payment can also be done in the form of promicery notes received by the party, or refundable donation receipt/guarantee notes, to be paid back in future.

5.11.3 Members of concurrent GAP governing council

Members of concurrent GAP governing council will take their fees in lien of their service, half amount of which will be charged on the fund of Central Executive Committee and half-half of the half amount will be charged on the funds of other two concerned executive committees.

5.11.4 Office bearers, Post holders and staff of the recruitment council

- 5.11.4.1 Will take the legally fixed fees in lieu of their services to the party, half amount of which will be charged on the Central Executive Committee and half on the concerned executive committee.
- 5.11.4.2 Will take fees from the new members, post holders, officers and staff for their selection and training services given.

5.11.5 MISCLLANIOUS

- 5.11.5.1 No member on executive committee will accept any amount as grant. Such amount will be illegal. Such grant can be received only on behalf of the party, in lieu of which, receipt recognized by the party will be given.
- 5.11.5.2 Any member, or any other person, organization institution, trust, company or firm can give short term or long term loan to the party, and authorize any person or institute of its liking to get it repaid back on its behalf.

- Promissory notes (Hundis)/work valuation notes to be paid back in future or refundable donation receipt or receipts/guarantee notes, recognized by the party will be given to the lender as a proof.
- 5.11.5.3 The central working committee will be verifying the membership of the Primary Members through the district (janapad) secretary general. It will submit the report to the party with recommendations, as to which member has not been proved true on the rules of membership. Membership of such member will be held null and void. But such member can submit a petition to the judicial council of the Voters Party International against such invalidation. Decision of the judicial council will be final.
- 5.11.5.4 Other five vertical executive committees of the party will regularly verify the membership through the respective local committees and will submit their report and recommendation to the concerned vertical executive committee.
- 5.11.5.5 The share of various vertical units in membership fee will be according to the following rules :
 - a) The vertical units will keep 50% of the membership received from their respective Active Members with themselves. The executive committee of the related constituency and the concerned voters councilors will be given half of that amount to be distributed as per rules formed by the vertical units.
 - b) To fix the amount of the Active Membership fee, will be function of the Central Executive Committee of the party.
 - c) Distribution of fund of fee collected from Primary Membership of the party among all vertical Executive Committees will be done as per the rules made by the central Executive Committee.

5.12 DISMISSAL, POSTPONEMENT AND TRANSFER OF MEMBERSHIP

The executive committee related to the member of the party will have the right to dismiss the membership, or to postpone for some years on the basis of description or to transfer into any counterpart assembly committee on the basis of

- 5.12.1 Nonpayment of fee;
- 5.12.2 Resignation or
- 5.12.3 Death, or
- 5.12.4 Insanity, or
- 5.12.5 Inactiveness, or
- 5.12.6 Removal or Recommendation by the related judicial council found guilty of illegitimate and/or Unconstitutional behavior.

5.13 DISCIPLINARY ACTION OF THE MEMBERS

- 5.13.1 Taking disciplinary action against any member of its executive committee or General Assembly all vertical executive committees and general assemblies will have right to postpone for some years or indefinitely dismiss or transfer into any other counterpart assembly or committee, the membership.
- 5.13.2 Voters Party International executive committee will have right to transfer the member, so dismissed postponed or transferred, to any other horizontal or vertical executive committee according to ones discrimination.
- 5.13.3 The member organized by the disciplinary action will have right to submit a petition for justice to the related judicial council and to appeal to the higher judicial council against that decision.

Chapter-Five

ARTICLE -6

REGULATIONS RELATED TO RIGHTS AND DUTIES OF THE VARIOUS UNITS OF THE PARTY

6.1 DUTIES OF THE ZERO MEMBERS-

6.1.1 Zero members are expected to keep their vigil whether the party or its office bearers are doing anything wrong. If they deem so, they will warn to their acquainted member

- in writing and send a copy of the complaint to the executive head of higher level of the organization.
- 6.1.2 The zero members will try to study the objectives of the party and their social utility if they deem that by bearing a little harm themselves, they can benefit a lot of people of society, they should attempt to be free from the assumptions which hinder the joyful acceptance of such harms.

6.2 RIGHTS OF THE ZERO MEMBERS-

Zero members will have the right in case their complaint and suggestion are not heard by high and higher, to the extent of the central executive of the Voters Party International, no response is received or they are not satisfied with the response they should do any such work according to their thinking which may even harm to the party.

Article
ARTICLE-7

GENERAL ASSEMBLY

There will be a body of the party on each and every level to approve the works of respective executive committee of the party, to sanction budget, functions, plans and activities, which will be called the General Assembly of the respective level and concerned executive committee. The president of the executive Committee of respective level will preside the meetings of the General Assembly. Initially there will be single level of the party, which will be called the Central Level. The founder members of the party will form an executive Committee, which will be called the Central Executive Committee (C.E.C.). These founder members will be treated as the founder members of the General Assembly of C.E.C. Latter on with the pace of development of the cadre of the party, the members of the General Assembly of the C.E.C. and the Members of the C.E.C. will be recruited as per the provisions of this constitution. The members of all types of electoral colleges made for the election of the president of respective level will be the members of the General assembly of respective level. Apart from these rules the other rules in connection to General Assembly will be as under:

7.1 CONSTITUTION OF THE GENERAL ASSEMBLY

7.1.1 CONSTITUTION OF THE LEGISLATIVE GENERAL ASSEMBLY, LGA -

The people who will enroll the maximum work force to the party activities will be entitled to get the membership of the Legislative General Assembly, LGA on priority basis. The vacant seats of Legislative General Assembly will be filled by the candidates of the Merit List made on the basis of Public Gathering Competition Assessment.

7.1.2CONSTITUTION OF THE DEVELOPMENTAL GENERAL ASSEMBLY, DGA

There will be a Developmental General Assembly, DGA parallel to the Legislative General Assembly, LGA of the party. This will be the body of those people who will render maximum economic contribution to the related general assembly. The vacant seats of Developmental General Assembly will be filled by the candidates of the Merit List made on the basis of financial contribution Competition Assessment.

7.2 RECRUITMENT IN LEGISLATIVE GENERAL ASSEMBLY

- 7.2.1 The recruit merit council will recommend the appointment of any person in the legislative general assembly, only when any person would submit a register of list of the zero members supporting any declared program of the party. An observer authorized by the selection committee would summon a meeting of the supporting members to approve the program, invited by the related member to testify the validity of the list, or
- 7.2.2 If the applicant himself calls for any special assembly, rally, demonstration, cordon, study camp service camp, purchase or sale or propaganda campaign etc. and an authorized officer of the recruitment council being present in the program personally, give report about the number of members.
- 7.2.3 The recruitment council will prepare a merit list, analyzing on the basis of figures received during the whole year if this list is longer than the seats of the Legislative General Assembly, LGA of the Voters Party International, it will send the list of extra members to the executive committee of the Voters Party International. If the number of seats is more, the remaining seats will be kept vacant the recruited legislative members will have a term of two years.
- 7.2.4 Because of such selection if the candidature of any person is cancelled and he has a grievance about the irregularity of the selection process, he can challenge the

selection of the recruited person in the judicial council of the Voters Party International and request for ones recruitment.

7.3 RECRUITMENT IN THE DEVELOPMENTAL GENERAL ASSEMBLY.

- 7.3.1 The number of seats in the Developmental General Assembly, DGA will be the same as that of the legislative general assembly. The territorial area of the seats will also be the same as that of the legislative general assembly.
- 7.3.2 Any member can apply for recruitment in the developmental general assembly, He/she has to mention the maximum financial amount which can be given according to ones capacity for the related financial session in the application form also this has also to be mentioned in which area and seat he wants his appointment.
- 7.3.3 The Recruitment council will keep all the application forms confidential as tenders. After analysis of all application forms coming for the seat from one area, it will open them before the members authorized by the judicial council in an open ceremony. Recruitment council will recommend to the executive committee for the appointment of the person desirous to give maximum financial contribution in any particular area. This member will be appointed for the term of one financial year. This appointment will be interim. If the person is successful in contributing the declared amount, as per ones desire, he will be finally regarded as the developmental member of the General Assembly on that seat for the next one year.

7.4 MERIT LIST OF THE GENERAL ASSEMBLY.

There will be an open competition for the recruitment in the General Assembly of the Voters Party International, to be organized by the recruitment council of the Voters Party International. The same council will decide the process of recruitment in the Legislative General Assembly, LGA and developmental General Assembly.

7.5 Rights of the members of general assembly

- 7.5.1 The legislative member of the General Assembly can declare null and void any order by the developmental member. Likewise the developmental member will have the same right veto against the legislative member of his area.
- 7.5.2 The Developmental General Assembly, DGA can declare as invalid any proposal passed by the majority of the legislative general assembly. The Legislative General Assembly, LGA will also have the some right, against the developmental general assembly.
- 7.5.3 Any legislative or developmental member can introduce any bill in his/her concern assembly. He/she can caste vote for or against at the time of voting to pass any proposal. He can do any such work or utilize his support in such a way so that the organization is benefitted as a group, or the member is benefitted himself provided the veto is not used against him.
- 7.5.4 Any member can apply for the membership of Voters Party International and its executive committee. After proving his claim providing money power or man power he can become the member of the executive committee.
- 7.5.5 After proving the claim for adding manpower one can become the president of the executive committee of the respective level and by proving the claim to add money power, can become the Vice President (Money Power) of the respective executive committee.

7.6 DUTIES OF THE MEMBERS OF GENERAL ASSEMBLY.

- 7.6.1 The legislative members of the General Assembly will try to establish co-ordination between the public of their area and needs of the Voters Party International executive committee.
- 7.6.2 If some member feels that there is other person present, stronger than him, who is desirous to work on his place, he will co-operate with him to provide opportunity for such person, even if he has to do some sacrifice for this.
- 7.6.3 No ex-member will behave, regarding any present member as his enemy, but will see the competition with a sportsman spirit.
- 7.6.4 Every ex-member will behave, so that he can maintain his previously earned prestige even without the strength of organization.
- 7.6.5 The present or ex-member will keep his close watch to recommend the recruitment of such persons in organization, who would be useful for the organization. However

no member will insist that the recommended person must be recruited only on the basis of his recommendation.

ARTICLE-8

RIGHTS AND DUTIES OF EXECUTIVE COMMITTEES

There will a Central Executive Committee and some other executive committees on various levels of the Voters Party International to perform the works to achieve the objectives of the party according to the party constitution, principles and policy-directions, in order to conduct various activities, related with the allotted amount sanctioned by the respective general assembly.

8.1 TYPES OF THE EXECUTIVE COMMITTEES AND THEIR LEVELS

The many executive powers of the Voters Party International will lie with the Central Executive Committee of the party. The main executive powers will lie with the president of the executive committee, who will perform his functions through the Bureau, constituted by one.

8.2 CONSTITUTION OF THE CENTRAL EXECUTIVE COMMITTEE

- There will be four vertical classes of office bearers of Central Executive Committee.

 The president will be at first level, Vice Presidents will be at second level, all other office bearers will be at third level and the Policy Director will be at Zero level.
- 8.2.2 There will be four organs of the Voters Party International executive committee. Which will be called Bureau, Board, governing council and Policy Directorate. The head of the Bureau will be called president, head of the Board will be called Vice President (Money Power), head of the governing council will be called Vice President (MIND POWER) and head of the Policy Directorate will be called Policy Director.
- **8.2.3** There will be a secretary general of the executive committee parallel to the president and Vice President (Money Power), to convey the expectations of the Bureau and Board to the Vice President (Mind Power), and the expectations of the Vice President (MIND POWER) to the Bureau and Board. Under whom the secretarial of the executive committee will function.
- **8.2.4** There will be a President- Voters Party International Fund in the secretariat of the secretary general who will maintain the detailed record o the income and expenditure of the Voters Party International.
- **8.2.5** President, Vice President (Money Power) and secretary general can appoint the vice-presidents, vice- Vice President (Money Power) and secretaries according to ones discretion, respectively.

8.3 RECRUITMENT OF OFFICE BEARERS OF THE CENTRAL EXECUTIVE COMMITTEE

8.3.1 ELECTION OF PRESIDENT OF THE EXECUTIVE COMMITTEE

8.3.1 The president of the Central Executive Committee will be elected by all the president of National, Hemi- national, Homeland, Country, Regional, Provincial and District level committees.

8.3.2 SELECTION OF VICE PRESIDENT (MONEY POWER) OF CENTRAL EXECUTIVE COMMITTEE-

The Vice President (Money Power) of the Central Executive Committee will be that member of the party who had given the maximum financial contribution as cash or services to the party in the last fiscal year. The President of the Central Executive Committee and the Vice President (Mind Power) should testify the fact unanimously. The term of Vice President (Money Power) will be one fiscal year.

8.3.3 ELECTION OF THE VICE PRESIDENT (MIND POWER) OF THE CENTRAL EXECUTIVE COMMITTEE-

The Vice President (Mind Power) of the central executive will be appointed by the President. On the advice of the Vice President (Money Power), the President will appoint any person as Vice President (Mind Power) of the central executive who will be the member of General Assembly of the National Executive Committee and will be the bearer of affinity and consciousness of highest level to the mind of the President.

8.3.4 ELECTION OF THE MEMBERS OF THE CENTRAL EXECUTIVE COMMITTEE-

Members of the Central Executive Committee will be elected by the president and the Vice President (Mind Power) unanimously in the number needed by the Vice President (Mind Power) to carry various responsibilities of the central executive committee.

8.3.5 RECOGNITION OF THE POLICY-DIRECTOR OF THE CENTRAL EXECUTIVE COMMITTEE-

The Vice President (Mind Power), the president, the Vice President (Money Power) and two third majorities of all the members of the Central Executive Committee will recognize any person, including himself as a policy-director of the central committee whose name shall be proposed by an organization recognized by the Central Executive Committee as Organization for Policy Supervision and Direction. In absence of the two third majorities, this post will be kept vacant. As far as possible the recognition will be given to such a person, for the post, who should be beyond any politics of caste, race, sect, country, party and self interest. Through the Policy Director the party could unite humanity instead of dividing it and on whose ideals; the central executive would like to be run. The Policy Director will remain on his post till the grace of two third majority of the central executive committee.

8.3.6 NOMINATION OF THE GENERAL SECRETARY OF THE CENTRAL EXECUTIVE COMMITTEE-

The secretary general of the central executive will be nominated by the President on the joint advice of Vice President (Money Power) Vice President (Mind Power). To be appointed the post of the secretary general, a person will be required to have a fixed certificate of qualification from any institution, conducted or recognized or authorized by the party.

8.3.7 Nomination of the In charge of Voters Party International Fund/Treasurer of Central Executive Committee-

The In Charge/President- Voters Party International Fund of the Central Executive Committee will be nominated by the President on the joint advice of Vice President (Money Power) and Vice President (Mind Power). The President- Voters Party International Fund will maintain the accounts of income and expenditure of the party. He will also be the in charge of the institution called party fund.

8.3.8 NOMINATION OF THE ASSISTANTS OF VICE-PRESIDENT (MIND POWER) OF THE CENTRAL EXECUTIVE COMMITTEE-

Assistants of Vice president (Mind Power) of the Central Executive Committee will be nominated by the president on the advice of the Vice President (Mind Power).

8.3.9 NOMINATION OF THE ASSISTANTS VICE-PRESIDENT (MONEY POWER) OF THE CENTRAL EXECUTIVE COMMITTEE-

Assistants of Vice-President (Money Power) of the Central Executive Committee will be nominated by the President on the advice of the Vice President (Money Power).

8.4 TERMS OF THE OFFICE-BEARERS OF THE CENTRAL EXECUTIVE COMMITTEE-

8.5 CONSTITUTION OF VERTICAL GOVERNING EXECUTIVES-

- 8.5.1 There will be three organs of all the vertical executive committees, which will be called Bureau, Board and Directorate.
- 8.5.2 The head of the Directorate will be called President, head of the Board will be called Vice President (Money Power) and head of the Bureau will be called Vice President (Mind Power). There will be a secretary general parallel to the Vice President (Money Power) and the Vice President (Mind Power) to convey the expectations of Bureau and Board to the President, under whom the secretariat of the executive committee will function.
- 8.5.3 The President or Vice President (Money Power) will decide the minimum numbers of the Bureau and Board but the maximum number in the Bureau and Board will not be

- more than 20% than the number of the respective developmental legislative general assembly.
- 8.5.4 No one person can remain on the post of the president for more than two terms. President will be that member of the Legislative General Assembly, LGA who had been performing ones capacity to add the most individuals in the program of the Voters Party International constantly since last three years. Term of the president will be three years. So for as possible the president will represent the most popular contemporary ideological class.
- 8.5.5 The president will appoint minimum and maximum 8 assistants for Vice presidents. Appointment of the assistants for Vice-Presidents will be made from such people who will enable the executive committee to have the representation of all types of representative ideologies as for as possible.
- 8.5.6 Likewise the President will appoint 1 to 8 Assistants of Vice President (Money Power).
- 8.5.7 The list of their ideologies for which the representation will be obligatory to recruit their representatives as Vice President or Assistant Vice President (Money Power) will be as under- Leftists, Rightists, Cultural Leftists, Cultural Rightists, Economic Leftists, Economic rightists, character builders, nation-builders.
- 8.5.8 The Vice president (Mind Power) will decide the number of secretaries and members of the Bureau of the executive committee.
- 8.5.9 The Vice President (Money Power) will decide the number of secretaries and members of the Board of executive committee.
- 8.5.10 The Vice President (Money Power) will be that member of the development General Assembly who had been contributing financial power to the Voters Party International in the form of cash or services. So for as possible the Vice President (Money Power) will represent the second most popular ideological class.
- 8.5.11 Head of the Directorate will be the President, who can maintain a Directorate for consultation and co-operation.
- 8.5.12 The President of Central Executive Committee will work as the assistant to the Policy Director. His/her main function will be to make compromise to remove any conflict occurred between the developmental and legislative general assemblies, to establish harmony among the various individuals and groups organized on the basis of ideologies, to remove the conflict between the Board and Bureau and between Vice president (Mind Power) and Vice President (Money Power), and to help for forwarding the cause of the party without hindrances and conflict.

8.6 VERTICAL EXECUTIVE COMMITTEES-

- 8.6.1 There will be a founder executive committee which shall be called as Voters Party International executive committee, or will be called as the Central Executive Committee.
- 8.6.2 There will be five vertical executive committees created by the Central Executive Committee. The constitution, procedure, rights and duties of these 5 types of vertical executive committees will be decided by the General Assembly of the respective executive committee.
- 8.6.3 Every vertical executive committee will have-
 - 8.6.3.1 its own constitution and flag.
 - 8.6.3.2 This constitution will be registered with the Central executive committee of the Voters Party International. Provisions of the constitution of any executive committee will be held null and void till the extent being hindrance in enforcing the constitution of the central executive committee.
 - 8.6.3.3 All executive committees will have separate jurisdiction and Working List.
 - 8.6.3.4 The Active Membership of the members of the party will be registered with one of the vertical executive committees of the Voters Party International. The same can be transferred time to time from one executive committee to another from smaller territory to larger, through the prescribed application form.
 - 8.6.3.5 Five executive committees will be called, Provincial executive committee, country executive committee, Homeland or Watani executive committee, hemi- national executive committee and National executive committee.

- 8.6.3.6 Every province of the Indian Union will have its own executive committee, which will have the jurisdiction of territory of every respective province.
- 8.6.3.7 The territory of the existing Union of India shall be the jurisdiction of the country executive committee.

8.7 VERTICAL EXECUTIVE COMMITTEES OF THE PARTY REGARDING FOREIGN AFFAIRS.

To fulfill the foreign interests of the domestic citizens of the Union of India, there will be some executive committees of the party to look the external affairs. These committees will be constituted at three levels called as Homeland or watan level, hemi-national or *prarashtra* level and national level. The organs, sub organs and various committees of the party working on the foreign affairs of the party will work to draft and intact the adequate international treaties; so that all the residents of the said territory could be legally entitled to get the membership of the party.

8.8 EXECUTIVE COMMITTEE OF WATAN OR OF INDIAN SUB-CONTINENT

For both the Hemi-nations, possibly for their each half-part, there will be an executive committee which will be called the executive committee of the Homeland/Watan.

- 8.8.1 There shall be an Executive Committee for the region of the south Asian watan of eastern Hemi-nation. This Committee will be called the south Asian Watan executive committee. The united territories of India, Pakistan, Bangladesh, Nepal, Sri Lanka, Maldiv, Bhutan and Afghanistan, will be called the Watani territory. There will be an executive committee for this territory which will be called the Homeland/Watani executive committee. The executive committees of the party looking the foreign affairs, will work for the adequate international laws pertaining to this region. This executive committee will work to satisfy the foreign needs of the domestic citizen of the India, like communal harmony, regional peace, security and economic growth of the citizens of lower and middle class.
- 8.8.2 There will be an executive committee for the Northern Asian region situated in the eastern Hemi-nation. This committee will be called the executive committee of the Northern Asian Watan. There will be an executive committee for the Southern region situated in the Western Hemi-nation. This committee will be called the executive committee of the South American Watan. There will be an executive committee for the Northern region situated in the Western Hemi-nation. This committee will be called the executive committee of the North American Watan.
- 8.8.3 As for as possible the one forth population and resources of the world will be covered in one region of Watan. This aim will be kept in the mind when the demarcation of the territories will be made for all four Watans or for four territories of the Homelands.

8.9 HEMI-NATIONAL / 'PRARASHTRA EXECUTIVE COMMITTEE

So for as possible the half part of the globe shall be called Hemi-nation. The executive committee formed for the region of the Hemi-nation will be called executive committee for the 'Prarashtra' or for the Hemi-nation.

8.9.1 EASTERN HEMISPHERE EXECUTIVE COMMITTEE

There will be an executive committee for the 'Eastern Prarashtra' or for eastern Hemi-nation. The jurisdiction of which will cover the China, eastern Russian Union, State territories of Japan, entire Africa and all the countries of South Asia as approved by the Voters Party International executive committee. This executive committee will work to satisfy the needs of the citizens of Indian Union, which may require the collective effort of the citizens of the eastern Hemi-nation, as for as possible.

8.9.2 EXECUTIVE COMMITTEE OF THE WESTERN HEMISPHERE

There will be an executive committee for the 'Western Prarashtra' or for Western Hemi-nation. The jurisdiction of this territory will include western America and state territories of those countries of Europe and Africa which are approved by the Central executive committee of the Voters Party International. This executive committee will work to fulfill those requirements of citizens of the Indian Union, which may need the collective effort of the citizens of the western Hemi-nation of the world.

8.10 EXECUTIVE COMMITTEE OF THE 'GLOBE OR RASHTRA' OR NATIOIN:

There will be National executive committee under which jurisdiction there will be all land and water bodies of the entire earth, and the whole space beyond a certain height and whole earth beyond a certain depth. The executive committee will work to satisfy those needs of the citizens of the Indian Union for which the collective effort of the citizens of this globe may be required.

8.11 ELECTION OF PRESIDENT OF THE VERTICAL EXECUTIVE COMMITTEES

- 8.11.1 A Primary Unit shall be set up at Booth level, where there are at least 15 active members and 75 primary members.
- 8.11.2 The General Assembly of the Booth unit of the party will consist of all active members of the respective Panchayat / Municipal Wards.
- 8.11.3 The General Assembly of the Booth shall elect a Panchayat / Municipal Ward Executive Committee consisting of below mentioned not more than 7 members and shall also elect a President. Name of the portfolios of members will be given by the regional executive committee of the party. The Booth President of the Party shall appoint the following office bearers:

- 8.11.7 The General Assembly of the Village/Panchayat/Municipal Ward shall elect a Panchayat / Municipal Ward Executive Committee consisting of below mentioned not more than 9 members and shall also elect a President. Name of the portfolios of members will be given by the regional executive committee of the party. The Panchayat / Municipal Ward President of the Party shall appoint the following office bearers:

Name of the portfolios of members will be given by the regional executive committee of the party. The Sector President shall appoint following office bearers from among the members of the Sector Executive Committee –

All the presidents of the executive committees of all the constituencies of legislative Assemblies will make the first Electoral College. In the second there will be president(s) of all the Regional executive committees.
- 8.11.37 In the election of executive committee(s) of Regions, there will be two types of electoral colleges. All the presidents of the District Committees of the region will make the first Electoral College. In the second there will be president(s) of the executive committee(s) of Province(s).
- 8.11.38 There will be three types of electoral colleges in the election of the president of the country executive committee. In the first there will be presidents of the executive committees of all the blocks of the respective country. In the second there will be presidents of the executive committees of all the Lok Sabha constituencies of the country. In the third there will be presidents of all the provincial executive committees.
- 8.11.39 There will be four types of electoral colleges in the election of the Presidents of executive committees of the Homeland/Watan. In the first, there will be all the Active Members of respective Homeland/Watan, who will enroll their name in the Voter List of Homeland as per the rules made by the Central Committee of the Party. In the second, there will be Presidents of all village executive committees of the respective Watan.

In the third, there will be Presidents of executive committees of all the Homeland Parliamentary Constituencies of the respective Watan and in the fourth, there will be Presidents of country executive committees of all the countries of the respective Homeland/Watan.

- 8.11.40 There will three types of electoral colleges in the election of the presidents of the executive committees of Hemi-nation/ Prarashtra. In the first, there will be all the Active Members of respective Hemi-nation, who will enroll their name in the Voter List of Hemi-Nation as per the rules made by the Central Committee of the Party. In the second, there will be the presidents of executive committees of all the Hemi-national Parliamentary Constituencies of respective Hemi-nation. In the third there will be presidents of executive committees of the respective Homeland/ Watans.
- 8.11.41 There will be three types of electoral colleges in the election of the president of the executive committee of the Nation. In the first, there will be all the Active Members of nation, who will enroll their name in the Voter List of Nation as per the rules made by the Central Committee of the Party. In the second, there will be presidents of the executive committees of all the national parliamentary constituencies of the Nation/Rashtra. In the third, there will be presidents of the executive committees of two Hemi-nations.
- 8.11.42 The presidents of all the vertical executive committees will have right to vote in the election of the president of the central executive committee. The vote value of the presidents of various vertical executive committees will be decided on the basis of the numbers of present Active Members of the Party currently living in the respective area.
- 8.11.43 It will be obligatory, in the elections being held for the post of the presidents of provincial, country, watani, hemispheric and global executive committees that the personal economic status of the candidates should be gradually less, lesser and least in order to smaller to larger territory. That means the candidate for the elections to be held for the post of the president of the executive committee will have the least economic status of wealth and the candidates for the elections to be held for the post of the president of the provincial executive committee will be the foremost. Central Committee of the party will declare the five slabs of the property for five governing vertical executive committees. An office bearer who is willing to contest the election of president of anyone vertical executive committee will have to proof whether he or she belongs with the concerned economic slab or not?

8.12 FUNCTIONS OF THE VERTICAL EXECUTIVE COMMITTEES

- 8.12.1 National/Global executive committee will organize the citizens of the world for their collective interests and for their personal economic growth.
- 8.12.2 Hemispheric executive committee will organize the Family heads of the respective Hemi-nation (*Prarashtra*) for their collective interests and for the economic growth of families of respective Hemi-nation.
- 8.12.3 Homeland/Watani Executive Committee will organize the Executive committees of villages/wards of the concerned watan and will work for the development of villages/Wards of respective Sub-continent or of Watan.
- 8.12.4 Country Executive Committee will organize the Block Executive Committees of the related country and will work for the development of block area or of local group of the villages of respective country.
- 8.12.5 Provincial Executive Committee will organize the Executive Committees of the assembly constituencies and will work for the development of the assembly constituencies.
- 8.12.6 Regional Executive Committee will organize the Executive Committees of the Districts and will work for the development of the respective district and will work as the regional assistant to the Central committee of the Party..
- 8.12.7 The party shall abide by the policy of *Dwaitadwait* (Monodualism) i.e, unity in diversity. To satisfy the collective interests like collective and common: problems, culture, civilization, nationality, economy, polity, legislature, judiciary and

- government; the various vertical executive committees of national, Hemi-national, Watan, country and province level of the party will work.
- 8.12.8 The Central Executive Committee of the party will have the right to formulate the rules regarding internal democracy, various types of membership, organizational elections of office bearers, term and conditions and rights and duties of members and office bearers and disciplinary actions thereon, amendment in constitution of the party, dissolution and division of the party itself.
- 8.12.9 Executive Committees of each level will have the right to introduce any bill in the respective general assembly, constitute the secretariat under the financial limitations made by the general assembly, use the salaries, allowances, facilities, pension, reward; determined by the general assembly, give benefit to ones enterprises, institutions, organizations under the circumference of the code of conduct decided by the general assembly.
- 8.12.10 Members of the executive committee will full earnestly enforce the methods formulated by the general assembly.
- 8.12.11 Members of the executive Committee, as for as possible do such work, which may not be cancelled for being illegal by the judicial council of the party.
- 8.12.12 The members of the Board and Bureau of the Executive Committee will keep mutual relations only through the Vice President (Mind Power) /head of respective committee.
- **8.12.13** The five vertical executive committees of the Voters Party International will have right to perform their functions by political manner, non-political manner or get the work done by various sub-executive committees of the various cells, fronts, operations, campaigns or by the conducted, affiliated or authorized organizations of the party.

8.13 RIGHTS AND DUTIES OF THE PRESIDENTS OF VARIOUS LEVELS

- 8.13.1 President will have right to utilize the members of the party for spreading his/her political ideology to the extent where the judicial council feels no any objection.
- 8.13.2 President will have right to use the fund of the treasury of the party under the limit determined by the concerned Development General Assembly.
- 8.13.3 President will have the right to strengthen his/her personal economic status by the rewards given by people for his/her public deeds.
- 8.13.4 It will be the duty of the President of various vertical levels to act considering the aspirations of the Developmental General Assembly, DGA in personal consumptions, the aspirations of the Legislative General Assembly, LGA in spreading his/her political ideology, aspirations of the judicial council and the manager in the organizational interest.

8.14 METHODS OF RIGHT OF VOTING OBTAINED BY THE PRESIDENTS OF EXECUTIVE COMMITTEES OF VARIOUS LEVELS

- 8.14.1 President of the Booth Executive Committee will have right to vote in the election of the president of the Village committee.
- 8.14.1 President of the village/ward executive committee will have right to vote in the election of the president of the Sector committee, of president of the committee of Parliamentary Constituency of Homeland and of Homeland/Watan committee of the party. Besides this the village/ward president will have right to vote in the election of the Watani president of the party alliance and also in the election of the president of Watani executive committee of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.1 President of the Sector Executive Committee will have right to vote in the election of the president of the Circle committee.
- 8.14.1 President of the Circle Executive Committee will have right to vote in the election of the president of the Block committee.
- 8.14.2 President of block executive committee will have right to vote in the election of the president of the district committee and Committee of Constituency of Provincial Assembly and to the country committee. Besides this the block president will have right to vote in the election of country president of the executive committee of the

- Party alliance and the president of Country executive committee of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.3 President of the executive committee of the constituency of legislative assembly will have right to vote in the election of president of the provincial committee of the party. Besides this the same president will have right to vote in the election of the provincial president of the party alliance and the provincial president of provincial executive committee of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.4 President of the Lok Sabha constituency executive committee will have right to vote in the election of the president of the province and in the election of the president of the country executive committee. Besides this he will have right to vote in the election of country president of the party alliance and in the election of country president of country executive committee of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.5 President of the executive committee of the constituency of Watan assembly will have right to vote in the election of the President of the executive committee of the constituency of Hemispheric assembly and in the election of the president of the committee of the Watan/homeland. Besides this he/she will have right to vote in the election of the president of the watan/homeland of the party alliance and the President of executive committee of watan/homeland of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.6 President of the executive committee of the constituency of Hemination/prarashtra assembly will have right to vote in the election of the President of the executive committee of the constituency of nation/ parliament and in the election of the president of the committee of the Hemi-nation. Besides this he/she will have right to vote in the election of the president of the Hemi-national president of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.7 President of the executive committee of the national parliamentary constituency will have right to vote in the election of the President of the executive committee of the nation. Besides this he/she will have right to vote in the election of the president of the national president of the party alliance and the national president of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.8 President of the provincial executive committee will have right to vote in the election of the president of country committee and central committee of the party. Besides this he/she will have right to vote in the election of the country president of the party alliance and country president of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.9 President of the country executive committee will have right to vote in the election of the President of Watan executive committee and in the election of the president of the central committee of the party. Besides this he/she will have the right to vote in the election of the President of committee of Homeland of the party alliance and the president of president of committee of Homeland of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.10 President of the Watan executive committee will have right to vote in the election of the president of the Hemi-national committee and in the Central committee of the party. Besides this he/she will have right to vote in the election of the Heminational president of the party alliance and in election of the Hemi-national president of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.

- 8.14.11 President of the Hemi-national committee will have right to vote in the election of the president of the national committee and in the election of the president of the central committee of the party. Besides this he/she will have right to vote in the election of the national president of the party alliance and also in the election of the national president of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.12 President of the national executive committee will have right to vote in the election of the president of the central committee of the party. Besides this he/she will have right to vote in the election of the central president of the party alliance and also in the election of the president of the Central Executive Committee of the umbrella organization recognized by the party to convene the political, non-political and para political organizations working for the mission of the party.
- 8.14.13 Presidents of the provincial, country, watani, hemispheric and National executive committees will have right to vote in the election of the president of the central committee but the value of their votes will be decided in the proportion of the number of the Active Members of the party present in the respective territory.

8.15 RIGHTS AND DUTIES OF THE VICE PRESIDENT (MONEY POWER) OF THE EXECUTIVE COMMITTEES OF VARIOUS LEVELS

- 8.15.1 Vice President (Money Power) will have right to utilize the members of the organization in order to spread ones enterprises to the extent where the judicial council would have no objection.
- 8.15.2 Vice President (Money Power) will have right to consume and enjoy the organizational power under the limit fixed by the legislative general assembly.
- 8.15.3 Vice President (Money Power) will have right to raise his/her own economic capacity and social status through the legitimate use of the members of the party.
- 8.16.4 It will be the duty of the Vice President (Money Power) of various vertical levels to act considering the aspirations of the Legislative General Assembly, LGA in personal consumptions, the aspirations of the Developmental General Assembly, DGA in his/her industrial growth, aspirations of the judicial council and the manager in the organizational interest.

ARTICLE-9

PARLIAMENTARY COUNCILS

There will be a central parliamentary council of the party to decide the directions regarding legislative works to be performed by the peoples representatives related to the party.

9.1 OBJECTIVES AND FUNCTIONS OF THE PARLIAMENTARY COUNCILS

There will be a central parliamentary council of the party. This council will be constituted by the central executive committee of the party. This council will regulate and co-ordinate the legislative functions and activities of the representatives of the party present in the legislatures of the various vertical levels like in the province(s) in the country(s) etc.

9.2 Organization and Procedure of the Parliamentary Council

- 9.2.1 Parliamentary council of the party will be constituted as far as possible on that every vertical level where any legislature exists and there will be a provision for elections to recruit the representatives in said legislature. These units will be called the vertical parliamentary councils of the party.
- 9.2.2 Every vertical council will be directed by its higher parliamentary council and will be guided by the central council while formulating directions for its concerned representatives of the people.
- 9.2.3 Any policy, rule and order made by any vertical parliamentary council will be null and void to the extent where they violate the policies and rules of the central council of the party or any higher parliamentary council.

9.3 CONSTITUTION OF THE PARLIAMENTARY COUNCILS

9.3.1 There will be minimum 3 and maximum 11 members including the central Vice President (Mind Power) of the party in the Central Parliamentary Council of the party. One representative of higher council will be ex-officio member of the lover council to convey the directions of the higher council to the lover one.

- 9.3.2 If there is only one parliamentary council is functioning in one province or in one country, then all the presidents of councils will jointly elect their representative to be sent to the central parliamentary council. He/she should be at least the member of any country level executive committee and should also be experienced to work constructively with the president of the executive committee of the country.
- 9.3.3 The representative of the parliamentary council sent to the Central Parliamentary Council through the method mentioned above, will appoint the Vice President (Mind Power) for that parliamentary council which is led by him/her.
- 9.3.4 There will be minimum three members in the parliamentary council of the country. Their maximum number will be equal to the number of provinces in the country.
- 9.3.5 There will be minimum three members in the parliamentary council of the province. Their maximum number will be equal to the number of district of the said province.
- 9.3.6 Number of members of the parliamentary councils of various levels can be increased or reduced by the permission of the president of the central parliamentary council.
- 9.3.7 The president of the executive committee of the respective vertical level will be the ex-officio president of the parliamentary councils of the concerned level.
- 9.3.8 The leader of the parliamentary party will be the ex officio member of the parliamentary council of the respective level.
- 9.3.9 The recruitment of the rest of members of the council will be done in the first meeting of the executive committee of the respective vertical level just after the formation of the committee.

ARTICLE-10

ELECTION AUTHORITY

There will be an Election Authority of the party, which shall conduct free, fair and confidential elections to recruit those office bearers of various levels of the organization of the party where election is mandatory. All the apex level committees and representative bodies of the party will be constituted through democratic election process. Nomination of members of such bodies, if at all provided, should be restricted to a minimum scale, not exceeding 1/3rd of the strength of the committee/body. No office will be hereditary or held permanently.

10.1 CONSTITUTION OF THE ELECTION AUTHORITY

- 10.1.1 The Election Authority will open its branches at each and every vertical level of the party organization. The vertical branches will conduct the elections for recruitment of office bearers of its level.
- 10.1.2 There will be 1 member in the Election Authority of the province level, 3 members in the Election Authority of the country level, 5 members in the Election Authority of the district level, 3 members in the Election Authority of the block level and 1 member in the Election Authority of the village/ward level. The president of the authority shall be counted as one of the member of the authority.
- 10.1.3 Any member of the Election Authority will not be entitled to become the member of the Election Authority of his/her home village/block/district/province.
- 10.1.3 The National Executive Committee of the party will appoint the president and members of the Election Authority of national/global level. There will be 15 members in the Election Authority of national/global level.
- 10.1.6 The rashtriya (global) election authority will from time-to-time formulate direction and codes of conduct to conduct the election Freddy, confidentially, and impartially. The right to formulate such code of conduct will be with all the election authorities of the party, situated vertically; but such directions and codes of conduct formulated by subordinate authorities will be null and void, to the extent they violate any direction or code of conduct of any higher election authority,
- 10.1.7 The term of members of election authority will be minimum 1 year and maximum 4 Years, as far as possible the term of the members of any authority will be of the same number of years, equal to the number of members, including the president of that authority, provided the term of any member will not be more than five years, on completing the term once, any member or president can be re-appointed for the second term to derive the advantage of higher experience,
- 10.1.8 No member or president of any election authority can be the member any executive committee of the party. To become the member of any such committee, he/she will

- be required to have left the member ship of the election authority before at least 6 months
- 10.1.9 The vertically situated higher election authority con remove any president or member of ones subordinate authority after giving notice for explanation to the accrued, the person thus removed will have right to appeal to the higher authority than the removing one. But in no way he/she will have the right for the second appeal.
- 10.1.10 No member or president will have right to get his work done by any other person. The authority can appoint or nominate some officers and staff to work collectively.

10.2 PHASES OF ELECTIONS

- 10.2.1 The commencement of the process of any election will be by preparation of election list of the concerned Electoral College. This work will be performed by the election authority of concerned level. On which the election is to be hold for recruitment of the public service.
- 10.2.2 The rules regarding registration of new names in the electoral list, or continuity of the already registered names or removal of the names from the said list will be the same as formulated by the Election Authority of the concerned level and sanctioned by the Election Authority of higher level.
- 10.2.3 The second step of the election will be the notification of said election. This notification will be issued by the competent election authority after sanction by the higher election authority. The detailed program of election will be declared in this notification.
- 10.2.4 In the third phase, nomination forms, legal verification of such nomination forms, the final list of participating candidates will be announced.
- 10.2.5 In the fourth phase, the election will be held according to the declared process.
- 10.2.6 After completion of polling there will be counting of votes and then declaration of result.

10.3 PROCEEDINGS OF ELECTION

- 10.3.1 The competent election authority will announce and publicize the place, methods, date and time of the election before at least 15 days, prior to the date of election.
- 10.3.2 For election, every election authority will prepare the per-forma of nomination forms for ones subordinate level. According to this per-forma only the nomination form will be submitted by the candidate oneself or by ones representative in presence of the competent election officer, on the date of nomination. On the next day the nomination forms will be verified before the candidates or before their representatives. Withdrawal of candidature will be done on the next day.
- 10.3.3 The names can be withdrawn as per the declared date and proceeding by the authority.
- 10.3.4 When the final list of the election candidates will be prepared after withdrawal of names then this list will be published in the shape of ballet paper by the authority. This ballet paper will be slicked on the door of election booth on the date of election, through which the voters will enter for voting.
- 10.3.5. The related authority will manage to ensure secrecy of voting, security of voting and impartiality of voting, they will adopt proper measures to regulate member of voters in the polling booth, to keep the supporters of the candidate at proper distance, to appoint the election agents of candidate on the spot of voting and for general security.
- 10.3.6. Voting can be done through any electronic machine too, instead of the ballot paper, provided the authority adopting such process, should inform the higher election authority and get its sanction for the method ensuring secrecy and impartiality of election
- 10.3.7. The authority will dispatch the sealed voting boxes after the completion of polling to the spot decided by the higher election authority. The elected candidate will be delivered such certificate by the authority.

10.4 PROCESS OF COUNTING VOTES

- 10.4.1. The voting boxes will be opened before the agents authorized by the candidates. Votes will be counted according to the fixed procedure. Number of voter obtained by the candidate will be announced and published by the authority.
- 10.4.2. The candidate fulfilling the fixed qualification essential to get elected will be declared elected by the concerned election officer and such certificate will be delivered to the elected candidate by the authority.
- 10.4.3. The related election authority will announce the impartial process of voting in case it is done through raising hand, or through any electronic medium, in its election notification.

10.5. Clauses regarding settlement related electoral disputes.

- 10.5.1. The electoral disputes will be settled by the judicial authority of the parity and /or by the law graduates of the university education and training centre and professional judges recognized by the election council of and authorized by the party.
- 10.5.2. The petitioner can submit his/her petition within 15 days after the declaration of election result before the parallel judicial authority, personally or through ones advocate or can send through post.
- 10.5.3 The judge will settle the petitions regarding election within 15days.
- 10.5.4. The judge, as far as possible will adopt the same process for settlement of the petitions regarding election, which is mentioned in the concerned clause, about the disciplinary action.
- 10.5.5. The party dissatisfied with the decision of the first judge of the judicial authority will have right to appeal to the court of the judge recognized by higher judicial authority. Petition of appeal will be submitted within a week after the decision of the initial court, at the time of hearing of the petition of appeal the petitioner can be asked to be present before the judge but at the time of his/her presence before the court, no advocate be allowed to enter.
- 10.5.6. No petitioner will have right for the second appeal in the case of election petitions. Till the higher judicial authorities and election authorities are not constituted on country level, the petition challenging the selection of office bearers, of country level executive committee and General Assembly will be selected by judges recognized by the central election authority and central judicial authority constituted by the central authority, the petitioner will have no right to appeal in the cases of such matters.
- 10.5.8. The petitions challenging the selection of members of the Central Executive Committee and the central General Assembly will be settled by the judges recognized by the central judicial authority. The petitioner can appeal, against the decision of the judge, obtained before the central executive committee. To accept any such petition it will be essential that at least 10% members of the executive committee should recommend so to the president or vice. President of the executive committee will be regarded as the settlement of the appeal. The decision of two third majorities will be treated as the final decision of appeal.

10.6. CLAUSES REGARDING RECRUITMENT ON THE VACANCIES-

- 10.6.1. In case of death, resignation or removal of any office bearer or member of any organ of the party will be regarded as vacant.
- 10.6.2. Any person can be recruited on the vacant parts by the president of the vertical higher executive committee restated with the unit. But such recruitment will be valid for only 6 months. After six months that part will be filled only by that process, which is provided in the constitution. If the part is filled by the constitution complete the constitutional term of the part.

ARTICLE-11

ELECTION CANDIDATE'S SELECTION COUNCIL

There will be a central Candidate Selection Council of the party to select the names of the candidates, authorized by the party, contesting election from various constituencies on the party

code and symbol, in the elections to be conducted for the recruitment of peoples representatives, in the various legislatures of different vertical levels. Its executive head will be called the president.

11.1. CONSTITUTION OF ELECTION CANDIDATE'S SELECTION COUNCIL

- 11.1.1. The Central Vice President (Mind Power) of the party will be the ex-officio president of the Central Election Candidates Selection Council, in short Central ECSC of the party.
- 11.1.2 The presidents of the parliamentary councils of the various units present on the vertical levels of the party will be the ex-officio presidents of the selection councils of the party.
- 11.1.3. Constitution of Election Candidate Selection Council will be made by all the members of the Parliamentary Council of the concerned unit, and by some other members. They will be called Area Expert Member.
- 11.1.4. Recruitment of Area Expert Member will be done amongst the members of the general assembly. The member of Area Expert Member of the party in any selection council will be minimum 2 and maximum Ten.
- 11.1.5. While selecting the members of Candidate Selection Council it will be kept in consideration that the person will have knowledge of organizational affairs, and will acquainted with the public sentiments of the area.
- 11.16. Recruitment of the Area Expert Member will be done by election process. In which the members of the General Assembly of the concerned unit can file the nomination as candidates. Election will be conducted by the election authority of the concerned unit. The process of election will be decided by the election authority of the party.
- 11.1.7. Till the selection council is not legally constituted for any unit, or the council is not active, the upper selection council will perform the function of the Selection Council through any ad-hoc committee constituted by it.

11.2 ORGANIZATION AND PROCEDURES OF BUSINESS OF THE ELECTION CANDIDATE SELECTION COUNCIL

- 11.2.1. There will be a branch of Election Candidate Selection Council of the party for every vertical level. These units will be called the vertical branches of the selection council.
- 11.2.2. Every Election Candidate Selection Council will recommend the names of the candidates for the election of various areas related to its own unit, to ones higher election council. For the purpose of winning the said election, for bringing the party in the proper direction guided by the constitution and for strengthening the party, the higher committee may order the subordinate election council to consider the same names / or may recommend other names instead of them. Thus the higher committee will prepare the final list of names of its level and send it to the central selection council. The final selection of the names will be done by the central selection council or by some committee or group authorized by it.
- 11.2.3. The process of selection of names will be a continuous process. The process for recommending and accepting the names can be initiated before maximum three years than the election of said constituency.
- 11.2.4. The selection council of the party working in the area of that legislature or that constituency, which is reserved as per rule of the alliance, for any other party or for any independent candidate, will send the final list of names of candidates along with the name of concerned party or name of independents; as if they are the candidates of own party.
- 11.2.6. The work of evolving the transparent and objective oriented process of selection of names will also have to be done by the candidate selection council, which will be effective after the sanction from the higher council.

ARTICLE- 12

JUDICIAL COUNCIL

There will be a judicial council of the party to watch whether the executive committee is functioning as per the constitution of the party or not and to settle any judicial petition submitted against any assembly, or committee, or against any member of the party. The executive head of the central judicial council will be called the Central president of the judicial council party.

12.1. RIGHTS AND DUTIES OF THE MEMBERS AND ADVOCATES OF THE JUDICIAL COUNCIL

- 12.1.1. President of the Central Judicial Council will be the member of the Central Executive Committee of the Voters Party International. Who will evolve the measures with the spirit of constitution of the party related to its procedure of constitution of the council, procedure of business, training and recognition of advocates, registration of petitions and procedures of trail thereof and enforcing judicial orders etc.
- 12.1.2. To be appointed as a member of the judicial council a person will be expected to have knowledge of Voters Party International constitution and who has also studied the social utility of various provisions of the constitution.
- 12.1.3 There will be one president and two members in the judicial council of the Voters Party International. Who will take the decision by majority or the president will take such decision by ones conscience, provided both the members authorize him/her to do so. The council have to give its judgment within six months after the registration of the petition, or within even less period. The council can fix maximum two dates for hearing for the decision. An appeal can be made against the judgment before the Central Executive Committee of Voters Party International (judicial office of the Vice President (Mind Power)) decision of which will be final.
- 12.1.4. Any decision given by the judicial council can be criticized and discussed with a view to its educational significance in the advocate council; but if the decision is changed by the two third majority of the advocate council only then the decision of the judicial council will be regarded as amended.
- 12.1.5. The number of members of the advocate council will be equal to the number of members of the legislative assembly. Membership of the advocate council will be decided on the basis of a merit list of members who will produce their certificate of having authorized in maximum disputes. From among that list, members in descending order will be in the advocate council, in equal member become its member only for two terms. Term of the member will be 4 Years.
- 12.1.6. The main function of the advocate council will be to formulate bills for the necessary amendment in the constitution of the party, criticize the decisions given by the judicial council, on private level or in the council, give legal advice to the executive committee through the judicial council according to the requirements of the general assembly, to become an applicant for appointment in the judicial council; to give services on charge after being appointed with some specific purpose by the executive committee, by general assembly, by Legislative General Assembly, LGA or by Developmental General Assembly, DGA and to criticize any bill passed by General Assembly privately or on council level.

12.2 Judges of judicial council

- 12.2.1 There will be some universities/institutes conducted or authorized by the party for the systematic training of the principles, theories, policies and rules of the party. Specialists having certificates from these institutions and recognized by the vertical executive committees, will work as the professional judges in the judicial authorities of the party.
- 12.2.2 The petitioners will be given right to authorize that judge only to issue judgment who is expected to be judicious by nature, to deliver judgment in cheaper cost and sooner and in order to make the judgments cheaper, rapid and judicious.
- 12.2.3. Every recognized judge/magistrate will be expected to keep the expenditure in the judicial process so much least that may be enough to earn normal livelihood so that people may be inspired to submit maximum petition to his/her curt. Every judge will inform while writing his verdict the cost of judicial proceedings and deposit 10% of that amount in the fund of the Voters Party International's respective level. The recognition may be withdrawn of the judge who would fail to deposit this money in party fund. Recognition can also be withdrawn of that judge too who will be found giving decision favorably with a view to some body's private interest.
- 12.2.4 The judges of the judicial councils of the country, subcontinent (*Watan*,) Hemination (*Prarashtra*) and global (*Rashtra*) level will not have the right to take service fees from the prosecutor or the dependant. The executive committee of the concerned level or its higher executive committee will manage to provide the honorarium for their subsistence.

12.3 IMPLEMENTATION OF THE ORDERS OF JUDICIAL COUNCIL

- 12.3.1. Every judge will send a copy of his verdict to the higher judicial council of the party. After receiving the copy of the verdict the higher council will implement the verdict through its parallel executive committee.
- 12.3.2. The concerned executive committee will order ones subordinate executive committee to implement the verdict thus received from any judicial authority within 15 days and ensure the enforcement of the said order.
- 12.3.3. While issuing the order regarding implementation of the verdict, the concerned executive committee can order to transfer the accused in any such organ of the party; the executive head of which has to objection for that.

12.4 MISCELLANEOUS PROVISIONS REGARDING JUDICIAL COUNCIL

- 12.4.1. Till the judicial education centers of the party and authorized universities and trained judges and advocates do not come into existence; the Vice President (Mind Power) s of the vertical executive committees of the party will be regarded as the ex-officio judges of judicial authority of the concerned level.
- 12.4.2. The right to take disciplinary action against the president of the executive committee, Vice President (Money Power) Vice President (Mind Power) and secretary general will be with the judicial authority of that very level. The ace used will have right to appeal only once to the higher level.

ARTICLE-13

PUBLIC SERVICE RECRUITING COUNCIL

There will be an organ of the party for recruitment of the adequate persons on the posts of Primary Members, Assistant Active members, Active members, office Bearers of the party on various levels, where election is not required for recruitment. This organ will be called the Public Service Recruiting Council. The executive head of the central Recruitment Council will be called Director General-Recruitment Council. One member of the Central Executive Committee will be the ex-officio Director General of the recruitment council.

13.1 CONSTITUTION OF PUBLIC SERVICE RECRUITMENT COUNCIL

- 13.1.1. The executive heads of the Recruitment Council will be called the Recruitment Director of the concerned vertical level.
- 13.1.2. The Central Executive Committee will appoint any such a person as a Director of Recruitment Council of the National (global) level of the party who knows the constitution, mission and philosophy of the party and who have knowledge and experience of the ethical and practical aspects of the organizational science.
- 13.1.3. Director of Recruitment Council of the National (global) level will appoint the Recruitment Directors of both the executives of the Hemi-nations on the advice of the Vice President (Mind Power) of the global level.
- 13.1.4. Director of Recruitment Council of the Hemi-nations (prarashtra) level will appoint the Recruitment Directors of the executives of the Watan (Homeland) or Subcontinent on the advice of the Vice President (Mind Power) of the Hemi-nations (prarashtra) level.
- 13.1.4. Director of Recruitment Council of the Watan (Homeland) or Sub-continent level will appoint the Recruitment Directors of the executives of the country on the advice of the Vice President (Mind Power) of the Watan (Homeland) or Sub-continent level.
- 13.1.4. Director of Recruitment Council of the country will appoint the Recruitment Directors of the executives of the provinces on the advice of the Vice President (Mind Power) of the country level.
- 13.1.5. The Director General of the Recruitment Council of the Central executive committee will be entitled to recruit any Active Member of the party as office bearer of the party at any level in any organ or sub-organ of the party for the augmentation of the activities of the party where the Recruitment Council is not constituted due to the scarcity of the fund and man power as per the provisions of the constitution of the party.
- 13.1.5. The Director General of the Recruitment Council of the Central executive committee will be entitled to authorize any Active member of the party as in

charge to recruit the people as member and as specified office bearer of the specified organ or sub-organ at specified level of the party organization.

13.2 FUNCTION OF THE PUBLIC SERVICE RECRUITMENT COUNCIL

- 13.2.1 Recruitment Council will ensure as per the provisions of the constitution the posts of the party should be filled by the proper persons having adequate type of caliber in adequate amount for the said post.
- 13.2.2 The council will evolve the resolution of useful mechanism to perform its functions and implement them after getting approval by the general assembly of concerned level.
- 13.2.3 The office bearers of the party will have right to recommend any person to recruit on any post of the party, but such recruitment made by such recommendation will be interim till having the sanction of the Recruitment Council.
- 13.2.4 The Recruitment Council may get co-operation of some technical persons, organizations, trusts, firms and companies to perform its functions; or the Council may authorize such persons on institutions for performing some special functions.
- 13.2.5 Central Executive Committee will ensure that the Recruitment Council could be able to work as an autonomous body of the party.
- 13.2.6 Branches of Recruitment Council will be opened right from the block level to the world level committees of the party. The respective branch of the Recruitment Council will be constituted on the each and every level of organization of the party where any executive committee is constituted.
- 13.2.7 The directors of the Recruitment Council will have a well equipped Directorate, established by law for which arrangement of funds will be done as for as possible by the council itself. The higher executive committee of the respective level will try as for as possible that the Recruitment Council should not face dearth of resources.
- 13.2.8 The details of the posts for which the council will evolve proposal of recruitment according to the party constitution and will get approval from the concerned General Assembly are as follows:
 - 1. Recruitment of Zero Members
 - 2. Recruitment of Primary Members
 - 3. Recruitment of Assistant Active Members
 - 4. Recruitment of Active Members
 - 5. Recruitment of Fundamental Members
 - 6. Recruitment of Voter Councilors
 - 7. Recruitment of Members of General Assembly
 - 8. Recruitment of Members of Executive Committees
 - 9. Recruitment of Presidents
 - 10. Recruitment of Vice Presidents
 - 11. Recruitment of Vice President (Money Power)
 - 12. Recruitment of Assistant Vice President (Money Power)
 - 13. Recruitment of Samadarshee or equicient Vice President (Mind Power)
 - 14. Recruitment of Concurrent Vice President (Mind Power)
 - 15. Recruitment of Secretaries
 - 16. Recruitment of Lawyers
 - 17. Recruitment of Judges
 - 18. Recruitment of Party Spokesmen
 - 19. Recruitment of Officers
 - 20. Recruitment of officials
 - 21. Recruitment of Security Directors
 - 22. Recruitment of Recruitment Directors
 - 23. Recruitment of Directors of Candidate Selection Councils
 - 24. Recruitment of Party Fund Vice President (Mind Power) s
 - 25. Recruitment of associate organizations/Trusts/Firms/Companies
- 13.2.9 The Central Executive Committee will have right to create new posts in the party organization or to repeal the present posts from the party organization.
- 13.2.10 Recruitment Council will prepare the proposal of proceedings and will get it approved by General Assembly related to starting new unit/organ or sub organ to the party at all levels or at specified level of the party organization or to dissolve an organ or sub-organ at all levels or at specified level of the party organization .

- 13.2.11 Recruitment Council will prepare the proposal of proceedings and will get it approved by General Assembly to conduct, to affiliate, to authorize new organizations/trusts/firms/companies with the party.
- 13.2.12 Recruitment Council of any level of the party will consider the applications received to affiliate or to authorize new organizations/trusts/firms/companies with the party. Such applications will be sent along with the recommendations to the higher level Recruitment Council for approval or for sending the said application at appropriate level of Recruitment Council for approval.

ARTICLE-14

GAP GOVERNIG COUNCIL

The GAP Governing Council will be constituted to mediate between the presidents and Vice President (Money Power) of the executive committees of the party and to mediate between two executive committees of the party situated each other at vertically and horizontally. There will be two classes of GAP Governing Council. One will be called 'Concurrent GAP Governing Council' in short 'CGGC' and the second will be called 'Samadarshee GAP Governing Council' in short 'SGGC'. Executive head of the CGGC will be called 'Rajdoot' (Ambassador) and executive head of the SGGC will be called 'Rajpanch'(state tribune). Party will co-ordinate and accommodate between two opponent representative ideologies, between two mentally hostile sects, and between two conflicting communities through these very councils. Party will get bilateral and multilateral agreements, contracts and treaties between the two or more parties from time to time.

14.1 CONCURRENT GAP GOVERNING COUNCIL (CGGC)

- 14.1.1 The GAP Governing Council constituted for vertically mediation between the two vertical executive committees of the party will be called the Concurrent GAP Governing Council.
- 14.1.2. The vertical council head situated between regions and county committee will be called Fourth Rajdoot (Fourth Ambassador), vertical Council head situated between county committees and Watan (sub-continent) will be called Third Rajdoot (Third Ambassador), vertical council head situated between Watan committees and Prarashtra (Hemi-nation) will be called Second Rajdoot (second Ambassador/embryo) and the vertical council head situated between Prarashtras (Hemisphere) and Rashtra (world/globe) will be called First Rajdoot (First Ambassador).

14.2. Samadarshee GAP Governing Council (SGGC)

- 14.2.1. The GAP Governing Council constituted to mediate between the two horizontal executive committees will be called Samadarshee GAP Governing Council (SGGC).
- 14.2.2. The parallel council heads situated between executive committees of the two provinces will be called Provincial Rajpanch (Provincial Tribune), council heads situated between executive committees of the two countries will be called Country Rajpanch/tribune, council heads situated between executive committees of two Watans will be called Watan Rajpanch or sub-continental Tribune and council heads situated between executive committees of two Hemispheres will be called Prarashtriya Rajpanch or Hemispheric tribune.

14.3 CONSTITUTION OF GAP GOVERNING COUNCIL

- 14.3.1 After the registration of the party, the Central Executive Committee of the Voters Party International will make bye laws regarding the constitution of GAP governing councils, in tune with the spirit of the party constitution. While formulating bye laws it will be considered that the bye laws and proceeding should be able to eliminate the conflict between the horizontal and vertical executive committees peacefully instead of violence.
- 14.3.2 To become the head of the GAP Governing Council the applicant should have an excellent capacity of expression in speech and writing. He /she have to submit details regarding qualification, expected office etc. He/she will have to state as to which two communities are the subjects of his study and experience about their sentiments, what are the main points of conflict between the two

- communities and which strategy he/she would apply to avoid or eliminate the violent conflict etc.
- 14.3.3 Posting of the Rajpanchs for horizontal mediation between two parallel executive committees will be done by the Central Executive Committee or by any other body authorized by it on the advice of by-lateral or multilateral consent of concerned committees.
- 14.3.4 No person will be made the head of GAP Governing Councils who had no certificate of related qualification, issued by that institute which is authorized for certification by the party.

14.4 RIGHTS AND DUTIES OF MEMBERS OF GAP GOVERNING COUNCIL

- 14.4.1. Every executive committee will establish dialogue with ones neighboring executive committee only through these inter-executive GAP Governing Councils.
- 14.4.2. The council members establishing bilateral or multilateral dialogue between provinces will work under the vertical council situated between provinces and country. Likewise, all the councils doing mediation between countries will be sub-ordinate to council situated between countries and Watan (sub- continent). Councils making bilateral or multilateral dialogue between the council of the Watan and Hemi-nation /Prarashtra will work under the vertical council situated between Hemi-nations and Rashtra /globe. The councils doing mediation between Hemi-nations and Rashtra will be sub-ordinate to Central Executive Committee of the Party.

ARTICLE-15

VOTERS PARTY INTERNATIONAL FUND

Party will constitute an organ to keep the accurate records of income and expenditure of the party and to keep records of certificates issued against donations, debts, services received by the party either in cash or in kind. This unit will be called Voters Party International Fund, in short party fund or VPI fund.

15.1. Constitution of Voters Party International Fund

- 15.1.1. The executive head of the Voters Party International Fund will be called managing director and the executive heads of the branches of the fund will be called managers.
- 15.1.2. The Central Executive Committee will appoint such a person as the manager of the Voters Party International Fund of the global unit of the party who had knowledge and experience of the theoretical and practical aspects of fund collection, banking, accounting and audit.
- 15.1.3. Central Executive Committee or any other body authorized by it will have right to fortunate rules regarding compulsion for some or all office bearers of the party for opening account in the Voters Party International Fund.

15.2 Function of the Voters Party International Fund-

- 15.2.1 Fund will develop the medium of mutual exchange among the party members. Party will pay through this medium to the debt on party, to office bearers, to members and to staff who are recruited in the party on the condition of conditional remuneration.
- 15.2.2 Party will manage funds to fulfill the judicious interests of that class of the society which is having no financial capacity of paying regularly for their political interests. Party will give a device of exchange medium recognized by the party to donors and loan provider in lieu of loans and grants received by the party.
- 15.2.3 Party will recognize any such exchange medium evolved by any trust or by any forum of political parties, by any alliances of political parties, by any non political and para political organizations, by any fronts and federations working at country level, international level, super-national level and global level to develop collective force of maximum people outside of the party who are working for the similar objectives.
- 15.2.4 Party will open the branches of the party fund unto block level to global level to facilitate availability of the domestic exchange medium developed by the party or

- the exchange medium recognized by the party on the local level. These local branches will be called the branches of the party fund.
- 15.2.5 Party will work with full earnestness so that the government should pay back the amount with the interest double than common to financers of the party. For this purpose it will transparently promised to the financers through the said exchange medium developed or recognized by the party. So that the expenditure occurred for fulfilling the objectives of the party should be charged on the very recipients of the economic advantages who are benefited by fulfilling the party objectives.
- 15.2.6 In order to keep accounts of income and expenditure systematically and easily; the party will regulate its economic activities in such a way, so that any economic transaction with the party could be done only through the medium of local branches of Voters Party International Fund. The receipts against sum withdrawn from the party fund and expended in favor of the party should also be issued through the medium of these branches; so that a transparent system of transaction could be developed in the political sphere.
- 15.2.7 Voters Party International Fund will prepare the proposal of useful methods to perform its functions and implement them after getting sanctioned by the general assembly.
- 5.2.8 Voters Party International Fund can solicit co-operation from some technical persons, organizations, trusts, firms and companies or authorize them to perform some of its special functions.
- 15.2.9 The Central Executive Committee will be responsible to ensure that the Voters Party International Fund should work as an autonomous body.
- 15.2.10 Where any executive committee will be constituted the related branch of the party fund will be necessarily constituted.
- 15.2.11 The Directors of Voters Party International Fund will have a well equipped and legally established Directorate for which arrangements of resources will be done as for as possible by the higher executive committee of the respective level. It will attempt that the fund should not face any dearth of reserves.
- 15.2.12 party must utilize the party funds for political activities and get its accounts audited during each financial year by Auditor on the panel of CAG and submit its copy to the Election Commission within a period of 6 months after the end of each financial year.

ARTICLE-16

Security Council

There will be a body of the party to ensure security of the life and property of the office bearers and members. This body will be called Security Council. The chief executive of the central Security Council will be called the Director General of the Security Council.

16.1 CONSTITUTION OF SECURITY COUNCIL

- 16.1.1 Central Executive Committee will appoint any such a member of its committee as the director General of Security Council of the central committee who will have the theoretical and practical knowledge and experience of the interior and external security, Intelligence and information of organizational structure of security forces.
- 16.1.2 The Vice President (MIND POWER) of the Central Executive Committee will appoint the director of the Security Council of Global level, on the advice of the Vice President (Mind Power) of the same level.
- 16.1.3 Appoint the directors of Security Council on every vertical level of the party will be made by the director posted at upper level with the advice of the Vice President (Mind Power) of the respective level.

16.2 FUNCTION OF THE SECURITY COUNCIL

- 16.2.1. Security Council will open its branches on every vertical level of the party, through which it will carry on its responsibilities.
- 16.2.2 Security Council will form a systematic organization of private security guards and have useful relations with other organizations, agencies and companies operating private security services.

- 16.2.3. The Security Council will formulate its methods in such a manner that the persons imbibed with national spirit, bravery and competent to work in the Security Council.
- 16.2.4. Information of the verdicts taken by the judges of the judicial council will be sent to the concerned parties through the medium of the concerned branch of the Security Council only.
- 16.2.5. Security Council of the party will co-operate with the government, administration and police in exchange of information regarding security of the party workers and preventing crimes.

ARTICLE-17

MASS COMMUNICATION COUNCIL

There will be a body of the party to disseminate and propagate the policies, rules and regulations, programs, objectives, decision, etc with proper manner and in correct words, which will be called the Mass Communication Council. Its central executive head will be called the Central Spokesman. One member of Central Executive Council will be the ex-officio central spokesman.

17.1 CONSTITUTION OF MASS COMMUNICATION COUNCIL

- 17.1.1. The Central Executive Committee will appoint such person as a global spokesman of the Mass Communication Council of global level who has understanding of the constitution, policies and philosophy of the party. He should have experience to work in the print and electronic media, should have knowledge and experience of theoretical and practical aspects of the information technology and should be the master of expression and argument. One member of the Central Executive Committee will be the in charge of Mass Communication Council.
- 17.1.2. Spokesman of the global level of Mass Communication Council will be appointed by the Vice President (MIND POWER) of the Central Executive Committee on the advice of the Vice President (Mind Power) of the global level.
- 17.1.3. Directors of the Mass Communication Council of every vertical level of the party will be appointed by the spokesman of the Mass Communication Council of higher level on the advice of the Vice President (Mind Power) of the respective level.

17.2 FUNCTION OF MASS COMMUNICATION COUNCIL

- 17.2.1. Mass Communication Council will utilize the modern technology of the audio-visual media, print media, multimedia, social media etc. to perform its functions. For this purpose the council will run some newspapers, periodicals, radio station and T.V. channels, etc. and have co-operation and affiliation with some running media institutions and will also authorize some others for some specific programs.
- 17.2.2. Mass Communication Council will work to extend the friendly relations of the party with those journalists, columnists, editors and owners of the media institutions who inculcate the thoughts in society useful for all.
- 17.2.3. It will also be the function of Mass Communication Council to convey the expectation of the common people to the office bearers and executive committees of the party and influence the decision of executive committees of various levels of the party to that extent where the constitution of party permits and discipline is maintained.
- 17.2.4. According to the spirit of party constitution and keeping itself under its provision the Mass Communication Council will have right to inspire the vertical executive committees and office bearers of various levels by criticizing the work according to the expectations of their post or unit.
- 17.2.5. In order to make the Mass Communication Council autonomous, the members of party would like to purchase the products and services produced by the council. Executive committees of the party will try that the Mass Communication Council should not feel dearth of resources.
- 17.2.6. Vertical units of the Mass Communication Council will be there right from block level to the global level.
- 17.2.7. The executive head of the Mass Communication Council will be called the spokesman of the related executive committee.

SUB-ORGANS OF THE PARTY

There will be some bodies operated by the party with the objectives to prevent the growth of problems immerged recently in society and to reduce and eliminate ultimately the politico-economic problems prevailing since long. Also with the objective to protect the judicious interests of the various communities of society, to empower various communities existing in society on the basis on representative thoughts. These bodies will be called the sub organs of the party. The Central Executive Committee of the party will have right to formulate methods regarding the relations between such bodies and executive committees of various level of the party.

18.1 CELLS, FRONTS AND OPERATIONS OF THE PARTY

- 18.1.1. The party will create and operate some bodies along with the various vertical executive committees of the party with the objectives to prevent, to reduce and to eliminate ultimately the problems prevailing since long. These sub-organs will be called the Cells of the party. The nomenclature of these cells will be made as an adjective added for related problem or need. Such as Disparity Control Cell, Environment Preservation Cell, Membership Cell etc.
- 18.1.2. There will be some frontal organizations of the party to protect and to nourish the judicious interests of the various constituents of society by their organized struggle. These frontal organizations will be called the Fronts of the party. Fronts will be named as adjective added with the related social and professional component of the party. Frontal organizations will be parallel cadre of the party organization constituted by the party.
- 181.3. Some emergency fronts of the party will be constituted for checking of for eliminating immediately the current problem, or constituted to face any instant challenge of the party. These fronts will be called "operation of the party". They will be named adding the word "operation" with the concerned challenge. Such operations will be started at the time of some calamity or any emergent crisis, attack on party, at the time of any special campaign launched by the party, etc.

18.2. CONSTITUTION OF CELLS

- 18.2.1. The Vice President (MIND POWER) of the central committee will be entitled to open cells of the party on the recommendations of a vertical executive committee of the party. On the approval of the Recruitment Council some of the Active Members of the party will be appointed as the office bearer of the committee of the cell of said vertical level.
- 18.2.2. The number of nominated members in the executive committees of the cells will be 7, 6, 5, 4, and 3 at the level of country, state, district, block and ward/village respectively.
- 18.2.3. There will be an in-charge for every cell at each and every level, who will be the member of the executive committee of the same level. Executive committee of the cell will work for creating methods and programs related to the jurisdiction of the cell and will take help from the Executive committee of the concerned level of the party.
- 18.2.4. For the coordination between the vertical executive committees of the cell, it will be essential to the presidents of the subordinate executive committees to consult with the president of the higher executive committee of the concerned cell while nominating the president for constituting the executive committee.
- 18.2.5. For opening of a new cell of the party a recommendation from any member of at least state level executive committee will be essential. All the higher executive committees will consider upon this recommendation and will send their respective reports along with the original recommendation letter to the central Vice President (Mind Power) of the party. The Vice President (Mind Power) will finally decide whether that cell should be opened or not. The central Vice President (Mind Power) of the party can authorize any one president of the executive committees from among the vertical executive committees to take final decision at his own level.
- 18.2.6. The list of cells will be published as schedule 4 of the constitution of the party.

18.3 FINANCIAL MANAGEMENT FOR THE CELL

- 18.3.1. Members of the executive committee of the cell can collect funds to promote their mission by collecting contribution through conducting membership campaign or fund collection campaign. But all type of money will be accumulated through the receipt books of the party which will be deposited in the related account of the party.
- 18.3.2. The 75% amount of the total sum collected by the cell will be spent by the Central Executive Committee of the cell and 25% will be spent by the executive committee of the relative level of the party.
- 18.3.3. Executive committee of the cell will give 25% amount received in its account to the higher executive committee of the party as its contribution to party.

18.4. CONSTITUTION OF PARTY FRONTS

- 18.4.1. The proceedings of constitution of any cell of the party will also be the proceeding of constitution of fronts.
- 18.4.2. After getting permission from the Vice President (Mind Power) of the party, the formation of the front will be initiated by the Vice President (Mind Power) itself. Vice President (Mind Power) will authorize a president of any executive committee from among the vertical executive committees for the constitution of fronts. This decision will taken keeping in view the geographical probabilities of the functions of the front.
- 18.4.3. After being authorized by the Vice President (Mind Power) of the party, the president and manager of the respective level of executive committee will nominate the president and manager of the front of their own level. They will be called the president and manager of the front of respective level.
- 18.4.4. President of the front will nominate persons according to the work nature for one's own executive committee and will constitute the subordinate executive committees of the front with co-operation of all the vertical executive committees of the party.
- 18.4.5. All presidents of various vertical levels of the fronts will be member of the higher executive committee of the party.
- 18.54.6. President of the country level committee of the front may nominate that much maximum member in the executive committee of the front, which will be equal to the member of provinces in the country. Likewise, the president of the front of provincial level will nominate that much maximum member in the executive committee of the front, which will be equal to the member of districts in the state.

ARTICLE- 19

ORGANIZATIONS ASSOCIATED BY THE PARTY

Such organizations, trusts, religious communities, groups, bodies, firms, companies which fully or partially adopt and implement the objectives and programs of the party but do not agree with the leadership of the party; will be called the Associate Organizations of the party working through their own organizational structure. Association of such organization will be made as per the proceedings given in Article-13.2.12.

ARTICLE-20

ORGANIZATION AFFILIATED WITH THE PARTY

Such organizations, trusts, religious communities, groups, bodies, firms, companies will be called "affiliated Organization, which fully or partially adopt and implement the objectives, programs and leadership of the party, but use their own cadre and organizational structure to implement the programs. Affiliation of such organization will be made as per the proceedings given in Article-13.2.12.

20.1 Process to affiliation the organizations

20.1.1. To affiliate any organization with the Voters Party International, an application has to be given to the president of that vertical level of executive committee with

- which the applicant organization is to be affiliated, according to the per-forma of application form provided in article 31.7 of the party constitution.
- 20.1.2. Here, organization means a voluntary organization whether it is registered with the government or not and means trust, firm or company.
- 20.1.3. Receiving the application form for affiliation, if the president sends it to the president of the executive committee of higher level and it is sanctioned by Vice President (Money Power) too, then the Vice President (Mind Power) will evaluate its probable utility available through that organization for the party as manpower and money power. On the satisfaction, if Vice President (Mind Power) recommends the higher Vice President (Mind Power) to affiliate the applicant organization with the party; then the affiliation certificate will be issued by the Vice President (Mind Power) of the higher level.
- 20.1.4. Any affiliated organization will have right to file anticipatory objection/caveat against the affiliation of one's rival organization, with a condition that it will have to prove, what losses will have to face by the party through its rival and it is capable to make up and compensate the expected contribution from the rival to the party.
- 20.1.5. Methods regarding affiliation of voluntary organizations, trusts, firms, companies and political parties with the executive committee of any level of the party will be formulated by the executive committees of various levels of the party from time to time. These methods will be finally approved only after getting sanction of the General Assembly of higher level along with amendments, if any.
- 20.1.6 Separate methods regarding affiliation and association will also be formulated by the same process mentioned above in 20.1.3.
- 20.1.7. Application for diminishing or enhancing the jurisdiction and territory of the affiliated or associated organization can be submitted in the office of the president of that level where the applicant organization is associated or affiliated. The proceeding of accepting such applications will be the same which is fixed for the affiliation and association of organizations.

ORGANIZATION AUTHORIZED BY PARTY

- 21.1 Every vertical executive committees will have right to authorize any organization, trust, firm, company or political party to perform any one or more works of the party on the basis of adequate conditions and contracts. But such right will not lie with the units lower than district level of the party.
- 21.2. A point wise and written agreement in clear language will be made with the organization to be authorized by any executive committee. Whether to register that agreement with the government will depend upon the parties making agreement.
- 21.3 The higher executive committees of the party will keep distance fully from the disputes, charges and counter charges created among the parties making such agreement.
- 21.4. Application about the expansion of jurisdiction of the authorized organization will be produced before the higher executive committee for study. The process to sanction of this application will be the same, which is already determined as the process of authorization for any organization of the party.

ARTICLE-22

CLAUSES REGARDING REGULATING RELATIONS OF THE PARTY WITH OTHER POLITICAL PARTIES WORKING ON THE SIMILAR OBJECTIVES OF THE PARTY

22.1. For mutual cooperation, adjustment of seats in elections, common demonstration for common issues, common education and training programs, and for uniting and consolidating the political strength of the unorganized masses tortured by common problems but divided among various castes, communities, religions, languages, countries and political parties; the party will cooperate with initiative to form the common forum, para-political and super national fronts and alliances along with some political parties whom objectives are partially or fully similar to the objectives of the party.

- 22.2. Party will form common front or alliance with the other political parties, only if the concerned parties will be agreed with the following policies jointly:-
 - 22.2.1. There will be a written constitution of the Alliance/Front/Forum.
 - 22.2.2. There will be a written agreement to form alliance.
 - 22.2.3. Every member party will write the name of alliance with ones name as school, colleges write the name of university and their Board along with their name.
 - 22.2.4. The executive committees of the alliance will be constituted on that every level wherever any type of election related to legislative boby will be present.
 - 22.2.5. Executive heads of the vertical executive committees of the alliance will be elected by the office bearers of concerned level of all the member parties collectively. The system of this election will be decided by the following methods:-
 - 22.2.6.1. Executive heads of the district level executive committee of the alliance will be elected by the executive heads of block committees of all member parties collectively.
 - 22.2.6.2. The provincial executive head of the alliance will be elected by the executive heads of district executive committees of the entire member parties collectively.
 - 22.2.6.3. Block level executive heads of member parties will jointly elect the head of country level executive committee of the alliance.
 - 22.2.6.4. Executive heads of village/ward level executive committees of member parties will jointly elect the head of *Watan* (Sub continent) level executive committee of the alliance.
 - 22.2.6.5. Family heads associated with member parties will jointly elect the head of the *Prarashtriya* (Hemispheric) level executive committee of alliance.
 - 22.2.6.6. Primary members associated with member parties and and fundamental members of the alliance itself will jointly elect the head of the *Rashtriya* (national/global) level executive committee of alliance.
- 22.3. The value of the vote of the related office bearers of member parties entitled to vote in the elections of executive heads of executive committees of various levels of the alliance will be decided in proportion of Active Member of the concerned area of the related party.
- 22.4. For the purpose of evolving collective strength for collective mission; the office bearers of member parties associated with the alliance will be separate, but there will be commonness in Primary Members of all the member parties. To achieve this objective the application forms of Primary and Fundamental Membership of all member parties and of alliance will be produced and issued by the office of the alliance. The member parties will conduct their membership campaign only on the application forms issued by of the alliance.
- 22.5. Judicial committees will be constituted as for as possible at each and every level of organization of alliance to check the conflicts, apprehensions, objections, injustices occurring among the member parties of alliance and their office bearers.
- 22.6. Voters Party International will form alliance or federation with only those political parties, which will make provision one to five mentioned above as the part of their constitution.

PROVISIONS ESSENTIAL TO WORK AS A POLITICAL PARTY AUTHORIZED, AFFILIATED, ASSOCIATED OR RECOGNIZED BY THE ALLIANCES OF PARTIES, OR FEDERATION OF ORGANIZATIONS

- 23.1. Adopting the membership of country level, international level or world level; of the alliance of political parties; the party could work within the Indian Territory as a party authorized, affiliated, associated or recognized by that alliance for the Indian Territory. The Central Executive Committee will have right to take any type of decision in this regard.
- 23.2. The respective executive committees of the party of provincial level, country level, Watan level, hemispheric level and global level; can form alliance with executive committees of other political parties of their level, or their branches, or any league or body to achieve their objectives with the condition of approval by ones higher executive committee of the party. They can also terminate such alliance with some provisions. In this regard the decision of Central Executive Committee will be final.

POLICY DIRECTOR OF THE PARTY

Such thinkers, respected persons, spiritual *Gurus*, spiritual leaders, whom cooperation may help to achieve the objectives of the party, may be recognized as the Policy Director of the party on the recommendations either by Sh. Bharat Gandhi or by any organization authorized by him.

24.1. RIGHTS OF THE POLICY DIRECTOR

- 24.1.1 Policy Director will have right to supervise and watch every activity of the each and every member of the Central executive committee. If the committee seems to divert from ones declared principles, objectives and deviate from means declared to achieve those objectives and if the Policy Director feels so, he/she will have right to call explanation from the president of the executive committee. The president will submit his written explanation within a month and if necessary, he/she will meet him personally to interpret the written explanation.
- 24.1.2 If Policy Director is not satisfied with the reply of the president, he/she will issue some point wise instructions, which according to him will be essential to drive the executive committee in right direction. If the Director does not see any improvement in the activities of the executive committee till one year, he/she will have right to publicize the explanation demanded by him, written answers that explanation, and instructions given by him. He will openly criticize the executive committee, build public pressure to save it from debasement, or will appeal to the people to withdrew cooperation from the then executive committee of the party, if he/she does not feel any improvement up till two years, at the first he will issue the warning letter to the present to resign from the post. This warning will be obligatory and within six months the president of the concerned committee of the party will have to resign, or the Policy Director will himself/herself resign from his/her post. The vacant post will be filled as per the rules of the Party Constitution.
- 24.1.3 Policy Director of the party will have right to establish any organization, sect, trust, group of followers, etc in his/her own leadership, operate them and help other political parties, organizations, to which he/she deems desirable.

24.2. DUTIES OF POLICY DIRECTOR OF THE PARTY WILL BE FOLLOWING

- 24.2.1. The Policy Director will work in para-political manner; he/she will not become the member of any political party, and will not run any political party under his leadership. As soon as he does so, he will cease to remain the Policy Director of the executive committee.
- 24.2.2. He/she has right to criticize publically only to the then executive committee recognizing him/her, not to the whole party. If he/she does so his/her reorganization will be automatically ended.
- 24.2.3. No Policy Director will issue any such instruction, which would be against any provision of the party constitution, or will curtail it. Such instruction will be null and void till the extent where it goes beyond any provision of party constitution or it goes against the basic structure of the party.

CHAPTER-EIGHT

ARTICLE- 25

INCLUSIVE CLAUSES TO ENSURE THE REPRESENTATION OF THE VARIOUS CLASSES DIVIDED SOCIAL, ECONOMIC, POLITICAL, AND CULTURAL, GENETIC AND GEHENIC BASIS

25.1. Party assumes that due to natural and cultural reasons there are an upper class is society economically, socially, intellectually, physically stronger and gently weaker than others. Due to various unjust customs and values, unjust provisions of the constitution of the India and various unjust laws majority is oppressed and economically exploited by the upper class and gently weaker class of the society. Upper and gently weaker class shifted the economic burden of privileges availed by them on the economically, socially, intellectually, physically weaker sections and shifted on gently stronger section of society. Consequently majority is facing dearth of resources to develop their inherent physical, mental, social and spiritual caliber generations to generations. This phenomenon is impacting badly on production of goods and

services since long. Due to this mismanagement of society, a non ending genocide of talent is observed and balance between population and production is disturbed. To stop such genocide of talents and to empower stronger gentility, to provide freedom from economic slavery to majority from various laws and various provisions of Indian constitution the party will formulate time to time some special provisions to be adopted as policy and programs. Such special provisions will be listed in Schedule-7 of the party constitution.

- 25.2. The Recruitment Council of the party will frame time to time the useful methods in order to include representation of the various classes of society classified on various vertical and horizontal levels on the basis of nature and culture.
- 25.3. Vertical executive committees of the party will propose the proposal of inclusive policy regarding recruitment in party on their level. After getting the sanction from the higher executive committee the Recruitment Council of the respective level will execute the proposed methods by getting it approved by the General Assembly of the respective level.
- 25.4. Rules, regulations, bye laws and provisions adopted under the inclusive policy of the party will be laid in a schedule this constitution.

ARTICLE- 26

PROVISIONS RELATED TO DISCIPLINARY ACTIONS FOR INSURING THE ABIDANCE BY RULES

The related executive committees of the party will have right to take lawful disciplinary action in order to ensure abidance of party constitution by the party members, office bearers, officers and staff and to prevent their anti-party acts. "The quorum should be minimum 1/3rd members of the committee/representative Body/Unit for the valid meetings of various horizontal and vertical committees and all representative bodies and units of the party. Violation of this rule will be the subject of disciplinary action."

26.1 LIST OF PROHIBITED DEALS, DESERVING DISCIPLINARY ACTION

- 26.1.1. Any act done with the objective of devaluation or disobedience of any office bearer, or executive committee, or cell or any organ of the party.
- 26.1.2. Any act, deliberately done against any established theory, policy, decision or program of the party.
- 26.1.3. Any acts regarding collecting money for ones selfish interest in the name of economic empowerment of the party through party membership, fund collection etc, and not depositing the said amount as per rules in the party.
- 26.1.4. Not co-operating in the policies, decision and programs of the party regarding vertical separation of power and innovative definition of nation-state, democracy, sovereignty, voter and voting right.
- 26.1.5. To behave on the public places in such way which is viewed as evil and condemnable by the residents of that area?
- 26.1.6. Any deed done by mind, work, or words with the intention to weaken the candidate authorized in any election according to the rules of the party and party alliance.
- 26.1.7. Any act regarding violation of code of conduct on the stage of any program sponsored by party alliance.
- 26.1.8. Act to defame the party and to work to spoil the strength of the party in the name of seeking justice, being angry with any office bearer of the party, committee or executive committee or any such unit of the party.
- 26.1.9. Any derogative act in the name of demanding justice before any institution or forum outside the party.

26.2. PROCEEDINGS OF DISCIPLINARY ACTION

- 26.2.1. Any member of the party or its office bearer can submit the petition before the competent vertical judicial authority of the party regarding taking disciplinary action on the basis of harm inflicted to oneself or to the party or both, along with the fixed fees, against any member or office bearer, or committee or executive committees.
- 26.2.2. The related judicial authority will ask the accused within a week after receiving the petition, by post or by hand on his/ her address to submit his/her written answer within a month.

- 26.2.3. After getting the answer, the authority will ask the petitioner to submit ones written response within a week.
- 26.2.4. After receiving the response of the petitioner the authority will prepare its verdict in written and send it to both the parties. One copy of this verdict will be send to the higher judicial authority for record. In any case there will not be a distance of more than six months between the date of the decision and the date of registration of the petition.
- 26.2.5. The authority will mentioned the calculated expenditure occurred in this judicial process in its verdict to manage the expenditure on the process of settlement of disputes the judicial council of the respective level will prepare methods from time to time.

26.3. PROVISIONS REGARDING APPEAL

- 26.3.1. Any member, office bearer, committee, or executive committee or any organ of the party punished by judicial proceeding of the party can file petition for appeal to the vertical higher judicial authority against the order of the subordinate judicial authority given punishment. This appeal will be called the first appeal. In the first appeal the dispute will be settled within three months as for as possible .Only higher judicial authority will have right to give more time than three months in any special case on the basis of sufficient reason.
- 26.3.2. The petitioner dissatisfied with the verdict of the first appeal can submit its petition before the authority higher than the first appellate judicial authority.
- 26.3.3. No right for the third appeal with lie with any petitioner.
- 26.3.4. The appeal against any verdict of the judicial authority of central level can only be made in the court of the people only through writing books, forming organization, by speech, or by any other propaganda medium. Reaction of the common people, and the force created by it and its works will be regarded as the order of the appellate judicial council.

26.4. ADVOCATES HELPING THE PROSECUTOR AND THE DEPENDENT

- 26.4.1. Every complainant and defendant will have right to seek help from professional advocate for legal consistence. Such advocates will help to prepare petition or to prepare counter of rejoinder on charge or without charging fees. Such advocate can also present himself before any judge to interpret his petition or its response, by the permission of said judge.
- 26.4.2. Any petitioner will have right to present himself before the judge during the first and second appeal, but petitioner will have no right to appear with councel in the matter of appeals.

26.5. PENAL CODE

- 26.5.1. There will be many schedules of charges. Every schedule will have its own penal code.
- 26.5.2. Under the charges of the first schedule the accused will be suspended for six months from its position in the party.
- 26.5.3. Under the charges of the second schedule, the accused will be suspended for two years with fine of Rs.1000/- to Rs.1000/-.
- 26.5.4. Under the charges of the third schedule, the accused will be suspended for five years with fine of Rs.1,00,000/- to Rs.10,00,000/-. the full am court of fine will be deposited in the party fund.
- 26.5.5. When the charge under the fourth schedule will be proved, the accused will be dismissed for ever from the party.
- 26.5.6. After proving the charges under fifth schedule the accused will be got arrested under the government law of the concerned province along will termination form the party.
- 26.5.7. The global (Rashtriya) General Assembly will have the right to classify the allegations for various schedules.

26.6 SPECIAL CLAUSE REGARDING DISCIPLINE

- 26.6.1. Any judicial authority may entertain the petition of the petitioner working under ones parallel or subordinate authority. No judge will have right to hear the petition of any higher member, office bearer or committee of the party.
- 26.6.2. The right to entertain any petition against any person who is the member of General Assembly of any vertical level of the party will be possible only by the permission of the executive committee of the concerned level.

26.7 CLAUSES REGARDING INTERIM ORDER

- 26.7.1. Judicial authority of any level will have the right that if deemed necessary, it would forth with inflict interim punishment as soon as the petition is received, on the accused.
- 26.7.2. Such interim order can be quashed by the higher executive committee till the final verdict comes.

CHAPTER-NINE

ARTICLE-27

CLAUSES REGARDING AMENDMENT IN THE PARTY CONSTITUTION, AND INTERPRETATION OF CONSTITUTION

- 27.1. The Central Executive Committee of the party will have the right to amend the constitution as per rules, to withhold some provision or add some new provisions to it, in order to secure the internal democracy within and to evolve the polity and economy based on real democracy outside.
- 27.2. The General Assembly of concerned level will have right to amendment in the constitution of the executive committee of concerned level by its two third majorities; provided, such amendment will be null and void till the extent, where it affect the basic structure of the party constitution. Such supervision will be made collectively by the Vice President (Mind Power) of the concerned level and the counterpart chief justice.
- 27.3. Amendment in the constitution of the Central Executive Committee will be done by the central legislative council. All the amendments done by the Central Legislative Council will be regarded in consonance with structure of the constitution.
- 27.4. Executive committee of any level will have right to make amendment according to the immediate requirement through ordinance. Such amendment can be enforced till the next meeting of the General Assembly of the concerned level is not hold. The amendment proposal will be effective for the only if ratified by the general assembly.
- 27.5. Any constitutional amendment or any provision of the bylaws of various organs of the party can be challenged for constitutional legitimacy, provided, such petition regarding the challenge, is countersigned by the Vice President (Mind Power) of the executive committee of any provincial or country level. Such petition will be firstly considered by the chief justice working at same level. Appeal can be made on the verdict of the primary court to the two conjugative higher courts.
- 27.6. Whenever there will be requirement to interpret the provision and rules of the constitution, such cases will be raised in form of a petition as per the method above mentioned in Para 4, in the same manner as if the constitutional legitimacy of the concerned provision or rule were challenged.

ARTICLE- 28

DISSOLUTION AND DISINTEGRATION OF THE PARTY

President, Vice President (Money Power) and Vice President (Mind Power) of the central committee of the party with the approval of national level General Assembly may merge the party into any other party/organization. Similar proceeding will be adopted to allocate the assets of the party as per the rules made for the distribution of assets of the party. They can submerge other parties, through the authorized person or through any executive committee of the party on proper level, if such party so decides. President, Vice President (Money Power) and Vice President (Mind Power) of the central committee of the party may take decision regarding the dissolution of the party with the consultation of all levels of the party.

TRANSLATION OF THE CONSTITUTION

The constitution will be translated into every language of the world as for as possible. The draft of the translation will be approved by the Central Executive Committee of the party. Central Executive Committee will do this work on the basis of the report of the judicial authority of the party.

ARTICLE-32

REGISTERS OF THE PARTY

Party office will keep some registers with its own office and will authorize to its various vertical committees to keep the registers for keeping the record s properly. The details regarding the register will be added time to time in this article of the constitution of the party.

ARTICLE-33

PROVISIONS REGARDING NEW ARTICLES, SECTIONS, SUBSECTIONS TO BE ADDED IN THE CONSTITUTION

New articles, sections, subsections added in the constitution by amending the constitution of the party will be listed in the Shedule-9 of the party constitution.

TECHNICAL TERMINOLOGY

DEFINITIONS OF WORDS USED IN THE CONSTITUTION

- **1 Active Members of the UNG-** Those Primary Members of the party who are defined as Active Member of the party.
- **2** Assistant Active Members of the Party- Those Primary Members of the party who fulfill the conditions of Assistant Active Membership of the party and who assists the Active Members to perform his/her job..
- **3** Alliance of the party- Means, the common forum or platform of political parties. By which the party evolve the collective Para-political force for some common objectives.
- 4 Capitalism- Means, a representative ideology in which the person or the group of persons and their offshoots are regarded as the most competent character to own, use and operate the means of production- like land, machine, savings, purchasing power, labor force etc, who become successful in accumulating money through whatever means. Economic Capitalists are those persons who regard the parallel relation of the state with various generations of the citizens in politics and regard series relation of the state with various generations of the citizens in economy. There are two types of capitalist people- the Macro Capitalists and the Micro Capitalist.
- **5 Character Builder-** A person who feels that whole society and polity may be improved by character reformation of individuals/social activists.
- **6 Communism-** Means, a representative thought, in which the all the citizens irrespective of economic status are collectively regarded as the most competent character to own, use and operate the means of production- like land, machine, savings, purchasing power, labor force etc. A person loving such representative thought is called Communist. There are two types of Communists- the Macro Communists and the Micro Communists.
- **7 Concurrent** (Samvartee)- Means, a justice loving mentality who imbibes with the spirit of doing justice among various vertical organs/units/bodies of particular organization or doing justice among various communities and representative thoughts classified vertically.
- 8 Constituency of parliament of families- Means, the legislative assembly or parliament of the hemispheric (prarashtra) level. Which is called Parivar Sabha or parliament of families? The constituencies of the parliament members constituting this legislative will be called family constituency, which will be related by the territory nearly equal to the four Lok Sabha constituencies of India.
- **9 Council of voter councilors-** Common Forum of voter councilors operated by GOD.
- **10 Country** (union of provinces)-Means, the nation states recognized by United Nations Organization, like Indian Union.
- 11 Creamy layer- PARTY will have inclusive policy according to this policy, provisions of special protection and reservation will be made in the PARTY constitution for some classes of society. People and families will be marked, who have got affluence or already been benefited through this provision. This border line of affluence thus marked will be called the creamy layer.
- **12 Cultural Communist-** Means a person of equality loving mentality, who realize that all the human being should be similar in cultural values irrespective of various communities linked with various sects, languages, traditions, ideals, topography, and irrespective of various nationalities.
- 13 Cultural leftists- Means, a person of the future loving mentality who wants to construct the new cultural values, new laws of social governance, new civilization, new morality and new code of conduct to be adopted by contemporary generations of one's community; is called Cultural Leftist.

- **14 Cultural Rightists** Means, a person of the past loving mentality who wants to restore the cultural values, laws of social governance, civilization, morality and code of conduct adopted by the past generations of ones community is called Cultural rightist.
- **15 Developmental Member** Member of the General Assembly recruited in the PARTY on the basis of competitive merit of giving maximum economic contribution to the party.
- 16 Economic Communists- Means a person of equality loving mentality, who realize that all the human being, should be equal in economic status irrespective of various levels of intelligence and irrespective of various pedigree and kinship. Economic Communists are those persons who regard the parallel relation of the state with various generations of the citizens in politics and in economy both.
- **17 Economic Freedom Movement** Means, a mass organization operated by GOD to recognize economic rights to the voters through *votership*.
- 18 Economic leftist- Means, a person of the future loving mentality who wants to evolve the economy related new values, new laws of social governance, new civilization to be adopted by the contemporary generations of one's community; is called Economic Leftist. Economic Leftists aspires for such economy in which the means of production should be complex and specialized and production should be maximized and consumption thereof should be available to all.
- 19 Economic Rightists- Means, a person of the past loving mentality who wants to restore the economy related values, laws of social governance, civilization adopted by the past generations of one's community is called Economic Rightist. Economic Rightists aspires for such economy in which the means of production were simple and consumption was limited.
- **20 Equiscient** *(Samdarshi)* Means, a justice loving mentality who imbibes with the spirit of doing justice among various horizontal organs/units/bodies of particular organization or doing justice among various communities and representative thoughts classified and regarded horizontally.
- **21 Federation for Economic Freedom** Means, the common forum of those non-political institutions, organizations, trusts, movements and campaigns which are working with the objective of giving economic freedom to the voters, through *votership*.
- **22 Fundamental Member-** Means, Primary Members of the alliance and ex-officio primary members of the party; the party affiliated with.
- **23 Gehenic** Basis- Means, behavior, observations, feelings and thoughts of human being occurred due to some of the genes of concerned person. Party assumes that there are Gehenic basis of some political representative thoughts.
- **24 Global Agreement on Poverty and Peace (GAPP)** Means a name of international treaty containing the resolution of amendments in the charter of United Nations Organizations drafted by Global Agreement on Peace and Progress and approved by GOD.
- **25 Global Association of Political Parties (GAPP)** Means that PARTY alliance, which the global executive committee of the party would like to be affiliated. GAPP means party alliance of global level of the party.
- **26 Global Citizens Fund** Name of mission friend organization of the party, which should obtain contribution and public loan and keep their account of the expenditure occurred for parliamentary approval of *votership* law, Rule of law also on world level, common citizenship and currency of the world through polarization of public opinion and mass awakening etc.
- **27 Global Organization for Democracy (GOD)** The collective forum of political parties; non-political, Para- political and super-national institutions, organizations, firms and companies affiliating with. By which the party creates common political and economic force to achieve long term objectivities of the party.
- **28 Global Citizens Fund (GCF)**-The name of authorized organization conducted by GOD for issuing the RDR, maintenance of record of demand and supply regarding R.D.R.

- **29 Hindu-** Means the person bearing specific belief; present in many of the sects, religious communities of the world all over, who regard the ancient books regarding social value and law, named as *Smriti Granthas and Sootra Granthas* and who regard the ancient axiom books named as *Vedas, Upanishads* etc.
- **30 Horizontal Governing Councils** Means, the horizontal management councils situated between two horizontal organs/bodies of the party organization to resolve the horizontal conflicts of two bodies.
- **31 Inclusive Policy-** Means, the policy of the party to ensure representation of various classes of society classified horizontally and vertically and divided on the basis of economic, political, cultural and consciousness levels and on the basis of identities.
- **32 Leftist-**Means, a person of the future loving mentality which feels that society is going from less pleasant age to better pleasant age from dark age to light age, from under developed to developed. There are two typists of leftist people-the Cultural Leftists and the Economic Leftists.
- **33 Legislator Member** Member of the General Assembly recruited in the party on the basis of competitive merit enrolling maximum members to the party.
- **34 Macro Capitalists-** Means, a person of the infra-structure loving mentality who is a supporter of investing the accumulated money in scientific discovery, road construction, electricity, railway, canal for affluent people, etc.
- **Member** Means Primary and Active Members of the party, Fundamental Member of the alliance of the party, Missionary Members; defined by the party constitution.
- **Micro Capitalist** Means, a person of the production loving mentality; who is a supporter of investing the accumulated money in production of consumer goods for public in place of infra structure.
- **37 Missionary Member** Means, primary or equivalent members of the Mission Friend Organizations of the party; like members of the non-political organizations, trusts and political parties etc.
- **38** National Foundation for Education and Research (NAFER)- Name of that authorized institute which is authorized by the party for education and training for the recruitment of various technical posts of the party, to formulate syllabus, conduct examination and give certificates of qualification.
- **Para-political-** Means level of understanding where commonness among various political parties could be observed and consequently impartial relations could be establish and impartial behavior could be made among those parties and among their office bearers. A Para-political person may generate the collective force of various political parties and of their office bearers.
- **40 Primary Member-** Means, Primary Member defined as per the constitution of the party.
- **41 Province- i.e. State-** The provincial territories recognized by the constitution of any country.
- **42 Representative Thoughts** Means; various opinions, view points and perspectives of individual obtained by birth or acquired through society; related to polity and economic system; related to any socially recognized thinker, related to group of individuals.
- **43 Region-** The part of area of a province or area of more than one province or more than one country as demarcated by the Central Executive committee to make the functions of the central committee convenient.
- **44 Rightist-** Means, a person of the past loving mentality which feels that society is going to more troublesome state from the less troublesome one, going to dark from light, going to under developed state from developed. There are two typists of rightist people-the Cultural Rightists and the Economic Rightists.
- **45 Super National-** Means, a level of understanding where commonness among various countries could be observed and consequently impartial relations could be establish and impartial behavior could be made among those countries. A Super-national person may generate the collective force of various countries and of political parties, organizations and citizens of those countries.

- **46 Vertical GAP Governing Councils** Means, the vertical management councils situated amidst two vertical levels of the party organization to resolve the vertical conflicts of two vertical bodies.
- 47 Vertical Separation of Power- Means a mechanism to repair and correct the theory of separation of state power by injecting the information of the science of engineering known as components of power. In the contemporary world only horizontal component of power is adopted in the separation of power, vertical component of power is unfortunately missed. Hence By correcting the traditional concept of separation of state power, establishing five tire government system from provincial to global level instead of contemporary two tire system from provinces to nation state or country level. Adding three new vertical floors in the order of the polity at the level of quarter world, half world and also at whole world level and distributing the powers/working list among newly added three vertical governments by separating the state power vertically.
- **48 Village Parliamentary Constituency** Means, constituency of the legislature at the level of Watan (sub-continental level); which will be constituted by three neighbor Lok Sabha constituencies of existing Indian Parliament?
- **49 Voter-** Adult citizen, whom names are enrolled in the Voters List made by the Election Commission of India. Those who votes to constitute the legislature of the state.
- **50 Voter Councilors-** A person, technically trained, who counsels and helps the voters to obtain and protect their birth economic share i.e. votership.
- **51 Voters Parliamentary Constituency-** Means, constituency of the legislature at the global level; which will be constituted by five consecutive Lok Sabha constituencies of existing Indian Parliament?
- **52 Voters Party international** The name of a political party; affiliated by GOD and member of an alliance of political parties named as GAPP; working to enact the votership law in all the countries, rule of law on world level, common citizenship, common parliament, common government, common court of the world, etc.
- **Votership Foundation** Name of the mission friend of organization of the party; working to give financial assistance to the persons, organizations, parties and institutions; engaged in polarization of public opinion and public awakening in order to formulate *votership* law.
- **54 Votership** The cash amount received regularly by the voters sent from the government as their share in the gross domestic rent of collective property of the voters'.
- **55 Votership Alliance of Political Parties (VAPP)-** Name of the common forum/platform of political parties working for the cause of votership.
- **Zero Members** Means, the member of voters party; defined as per the constitution of the party; who are indifferent to the party constitution, or irregularly co-operate with the party, at their convenience or are literal opponents of the party but their names are written in the Zero Membership Register of the party through any Active Member of the party.
- 57 Hemi-nation- Means Eastern or western world.
- 58 Prarashtra Means Eastern or western world or Hemi-nation.
- **59** Hemispheric- Means Eastern or western world, Hemi-national.
- **60** Rashtra- Means Eastern and western world collectively or means -nation.
- **61 Watan-** Means a block or group of the neighbor countries. Neighbor countries of a sub continent. One state of Hemi-nation.
- **62 Dwaitadwait (mono-dualisic) principle of sovereignty-** Means Concept of sovereignty as propounded by contemporary political philosopher MR. Bharat Gandhi of India.
- 63 Theto power- Means globally recognized power of provinces to protect their
- **64** Political and social financing- Means economy of Politics.

2.2 WORKING LIST OF PROVINCIAL EXECUTIVE COMMITTEES-

- 1. Democratization of political power and its protection.
- 2. Elimination of poverty through means of employment given by government or by production companies .
- 3. Protection of *Dharmik Government*.
- 4. Forming laws related to indirect taxes and enforce them.
- 5. Forming laws regarding gold based monitory policies and enforcing them.
- 6. To promote researches on the progress of technology for more production.
- 7. To protect and nourish the economic interests of the producers, especially of formers.
- 8. To protect and nourish the economic interests of the purchaser.
- 9. To make law related of the decentralization of political power and implementation thereof.
- 10. To save economic resources for the future generation.
- 11. To do social management through character building.
- 12. Empowerment of the market.
- 13. Empowerment of the preachers of traditional life values of provincial community including such saints and teachers.
- 14. To check the population growth rate.
- 15. Theto power to the provincial governments for protection of provincial culture.

2.3 WORKING LIST OF COUNTRY LEVEL EXECUTIVE COMMITTEES

- 1. To fulfill the economic needs of the block management committees of the country.
- 2. To work for erecting institutional structure for vertical separation of state power.
- 3. To make every voter participant in the total accumulated domestic tax collected by the state through the medium of votership.
- 4. To satisfy the private financial needs of the members of the village management committees of the country for enhancing their efficiency.
- 5. To pass the financial bill in the Indian parliament regarding repayment of loans on higher interest rates than the Reserve Bank of India, taken from banks, institutions and organizations authorized by the party for receiving public debts with the objective of meeting the expenses occurred on public awakening campaigns and elections of legislative assemblies and of parliament for polarization of mass opinion on the issue of right of votership.
- 6. To make a provision in the proposed law related to votership to provide regular service fees minimum 5% of the votership amount to the Voter Councilors, certified by the organizations, firms, trusts and companies and recognized by the party.
- 7. To work for making legal provision of political and social financing in proportion of obtained votes to those election candidates who succeeded to obtain minimum number of votes in the election of Lok Sabha.

- 8. To increase Grass Domestic Production by enhancing the mental efficiency and self confidence of the voters through the provision of providing right of reservation of sitting seats to travel by railway.
- 9. By forwarding the social issues discussed during the international treaty named as the General Agreement on Tariffs and trade, GATT; make efforts for new treaty to curb the international problems emerged and aggravated by GATT treaty and making efforts to enact new international laws for free movement of labor, global citizens, super national saints, global statesmen, by liberalizing the polity and international political order.
- 10. Making legal provision to travel by air for free of cost at least once in life time for minimum 200 km on lottery basis for the poor voters who desire so. So that national affection may be inculcated among each and every voter.
- 11. Working for making legal provision to reshape the state structure according to the Dwaitadwait (mono-dualisic) principle of sovereignty.

2.3 WORKING LIST OF THE COUNTRY LEVEL EXECUTIVE COMMITTEE OF INDIA

- Developing India as such a strong country of the world so that all the citizens of all the countries of the world and all the backward countries would begin to the regard India as their global guardian.
- 2. Making new laws to implement the provisions of section 38, 39 and 51 of the Indian constitution.
- 3. To implement the policy to provide the employment to brain, instead of hands of citizens through the mechanism of votership.
- 4. Making legal provision of high taxation and ceiling on right of inheritance to restrain the offshoots of billionaires becoming billionaire freely, without condition of work and of test; and making legal provision of line of richness, like poverty line. So that no person should become so powerful to make the party president ones slave by the enormous strength of political financing.
- 5. Making legal provision to adopt new direct tax system for optimum production of country's wealth and reducing black money in order to reduce economic disparity and pay back foreign debt.
- 6. To give inclusive reservation to Scheduled Castes and Tribes and to OBC.

- 17. Working to provide status of United Nation Government (UNG) to the United Nation Organization (UNO) by ratification of proposed GAPP treaty.
- 18. Working to giving direct voting right to the heads of the families living within territory of Hemispheric Government, to elect the chief of the executive of *Prarashtra*.
- 19. Working to giving direct voting right to the heads of the management committees of the villages and of wards present within the territory of Watan Government, to elect the chief of the executive of *Watan*.
- 20. For the purpose of decentralizing the political power working to give right to vote to the management committees of the blocks, along with the parliamentarians to elect directly the prime minister of the country.
- 21. Working for sanction of GAPP treaty to adopt five tire government systems instead of the existing two tires.
- 22. Working for sanction of GAPP treaty to recognize the conditional South Asian Citizenship and conditional World Citizenship.
- 23. Working for sanction of GAPP treaty to recognize constitution of South Asian Parliament and World Parliament.

RULES, REGULATIONS, PROVISIONS AND BYE LAWS ADOPTED UNDER THE INCLUSIVE POLICY OF THE PARTY

- 1. The party shall work to provide reservation in the legislature to the section of society living in the BPL (bellow poverty line) and living between the slab of income tax and BPL in the ratio of their population.
- 2. Benefit of reservation availed by the SC/ST/OBC class will be divided among the income tax payers, Above poverty line and BPL class as per their ratio in population of respective class.
